City Council Meeting July 8, 2025



INTRODUCTION

- City Council requested staff to bring forth a report on the scope of work of Commissions and Committees, particularly as it pertains to Commissions and Committees providing recommendations to City Council for their consideration.
- In September 2023, the City Council reviewed the City Committees, including their scope of work, membership, criteria for forming Ad Hoc committees, and the alternate positions. Based on the direction provided by the City Council; staff incorporated the recommended changes and revised Council Policy 000.2 (City Council Appointed Advisory Committees and Boards), as well as updated the Commission and Committee Handbook.

CITY COMMISSIONS AND COMMITTEES

COMMISSION/COMMITTEE	MAIN FUNCTION
Planning Commission	Considers development projects and planning applications
Parks and Community Services Commission	Provides input relating to parks, parkways, recreation programs and community services
Arts Commission	Focuses on investments in the arts
Access, Building, Fire & Housing Board of Appeal	Advises on matters pertaining to building construction
Housing and Public Service Grants Committee	Considers activities funded by U.S. Housing and Urban Development Department (HUD) and Community Development Block Grants
Mobile Home Park Advisory Committee	Reviews matters concerning mobile home parks
Finance and Pension Advisory Committee	Advises on significant financial matters, the budget, and impacts
Animal Services Committee	Advises on services for animals
Fairview Park Steering Committee	Evaluates the Fairview Park Master Plan and park enhancement opportunities
Active Transportation Committee	Plans and implements an Active Transportation network
Traffic Impact Fee Ad Hoc Committee	Advises on updating and the revision of traffic impact fees



DISCUSSION

- The Municipal Code delineates Planning Commission recommendations to the City Council.
- The Municipal Code articulates that the Parks and Community Services Commission and the Arts Commission are to report its findings and recommendations to the City Council on various subject matter, however, it does not state how.
 - The City Council may want to specify the pathway in which to receive recommendations from the City Commissions.
 - Staff suggests City Council opt for a similar approach as the one currently in place with the Finance and Pension Advisory Committee.

A memorandum from the Chair will be provided to the City Council as to their recommendations. A majority of the Commission must agree on the recommendation.

• Currently, City Committees communicate and provide City Council with updates through a memo, an annual report, or they report out to the Council liaison, per the Commission and Committee Handbook.

Problem:

A Commission without a Voice

The Costa Mesa Arts Commission is tasked with advising Council on the city's cultural future, but it lacks the tools to do so effectively. With no reporting process, no way to initiate recommendations, and no formal role in branding, capital projects, or funding discussions, the Commission cannot fully carry out its mandate. This undermines Costa Mesa's identity as the "City of the Arts."

Structure

No formal process for memos, presentations, or Council responses, unlike other bodies.

Voice

No mechanism to create or lead subcommittees despite clear authorization in municipal code.

Visibility


No budget authority or branding role, despite the Master Plan's call to "elevate the status of arts and culture."

Solution

To fulfill its mandate and help Costa Mesa live up to its identity as the "City of the Arts," the Arts Commission needs clearer authority, strategic tools, and formal pathways to contribute. These proposals build on existing ordinance language and Master Plan goals, and they're ready to implement.

STRUCTURE

Create a formal reporting process to City Council.

FUNDING

Establish a dedicated Public Art Fund used exclusively for visible, community-facing public art.



VOICE

Clarify and affirm the Commission's right to form subcommittees and bring forward recommendations.

IDENTITY

Involve the Commission in civic identity efforts, including signage and visual design.

INTRODUCTION

- Currently, the City does not have a Code of Ethics and Conduct established.
- The goal of the Code of Ethics and Conduct is to ensure public confidence in the integrity of local government elected and appointed officials.
- Establishing an ethics code promotes an honest, effective, and accountable city government, encouraging high standards of behavior by public officials, and assists with decision-making.
- The intent of the Code of Ethics is to achieve fair, ethical, and accountable local government for the City of Costa Mesa.
- Staff conducted research and provided two Code of Ethics and Conduct examples for reference and consideration:
 - City of Irvine (Attachments 2 and 3) and City of Gardena (Attachment 4)
