PUBLIC COMMENTS - MATTERS NOT LISTED ON THE AGENDA

Flo Martin, Costa Mesa, spoke on residents living in fear and requested increased police presence to protect residents.

Speaker, voiced opposition to ICE's tactics, requested a resolution prohibiting assistance to ICE, and advocated for federal immigration agents to identify themselves, refrain from wearing masks, and have body cameras turned on, and spoke in support of public comments via zoom.

Dennis Okholm, Costa Mesa, voiced opposition to ICE's tactics, requested a resolution prohibiting assistance to ICE, and advocated for federal immigration agents to identify themselves and refrain from wearing masks, and spoke on the movie "A Day Without a Mexican".

Nancy Young, Costa Mesa, voiced opposition to ICE's tactics, spoke on residents living in fear, and spoke against racial profiling.

City Council reconvened at 6:58 p.m.

Speaker, Costa Mesa, voiced opposition to ICE's tactics, requested a resolution prohibiting assistance to ICE, and advocated for federal immigration agents to identify themselves and refrain from wearing masks.

Speaker, expressed support for ICE and voiced opposition to illegal immigration.

Nately Foley, Costa Mesa, voiced opposition to ICE's tactics.

Speaker, voiced opposition to ICE's tactics, requested a resolution prohibiting assistance to ICE, and advocated for federal immigration agents to identify themselves and refrain from wearing masks, and requested a legal defense fund.

Speaker, Costa Mesa, voiced concerns regarding meeting decorum, ongoing parking challenges and permit parking, vehicles left stationary for extended periods, and persistent littering.

Speaker, spoke on incidents involving federal officers facing violence and voiced opposition to illegal immigration.

Speaker, Costa Mesa, voiced opposition to ICE's tactics, requested a resolution prohibiting assistance to ICE, and advocated for federal immigration agents to identify themselves and refrain from wearing masks.

Speaker, spoke on racism, using mobile alerts to warn residents about immigration activity and spoke on residents living in fear.

Speaker, voiced opposition to ICE's tactics and acknowledging when something is wrong.

Speaker, spoke on national overcrowding, rising housing costs, and foreign investment in real estate.

Dianne Russell, Costa Mesa, spoke in opposition of hate and racism, spoke on residents living in fear, and is against masked agents in unmarked cars.

Speaker, voiced opposition to ICE's tactics, spoke on spreading love, spoke on racial profiling, and spoke on residents living in fear.

Evan Hernandez, former Vanguard University student, voiced opposition to ICE's tactics, supports the Sanctuary State laws, spoke on caring for all community members, and is opposed to collaboration with federal immigration agents.

Speaker, Costa Mesa, spoke on open immigration and against deportations.

Speaker, spoke on offering a conduit to help illegal immigrants to become legal, and spoke on banning fireworks in the city.

Speaker, Costa Mesa, spoke on protecting all residents, and requiring federal immigration agents to identify themselves and refrain from wearing masks.

Speaker, spoke on supporting the Council to protect residents, and spoke on working together against hatred.

Speaker, spoke on federal government policies causing fear in the community.

Sue Lester, thanked the Costa Mesa Police Department for their presence, urged the City Council to actively support efforts that make residents feel heard and secure, requested the Farrell Harrison complaint be referred to the District Attorney's office, spoke on adopting an ethics code, spoke on equal rights and equal treatment, and spoke on free speech.

Juana Trejo, thanked the people who voiced opposition to ICE's tactics and thanked the community who contributed food and donations, thanked the Costa Mesa Police Department, spoke on the fight against racism, and requested the City Council to take action.

Roberto Herrera, Resilience Orange County, thanked previous speakers who are in support of peace, spoke on having a constructive dialogue on due process and human rights, spoke on evictions taking place in Costa Mesa and requested an emergency ordinance for an eviction moratorium, spoke on tracking evictions due to immigration actions, and requested additional rental assistance funds.

COUNCIL MEMBER COMMITTEE REPORTS, COMMENTS, AND SUGGESTIONS

Council Member Marr thanked everyone who spoke and thanked the Police Department, addressed the importance of due process and the need to document unlawful detentions by ICE, spoke on contacting the Orange County Rapid Response Network or call 911, spoke on local businesses are not obligated to allow ICE agents without a warrant, requested to place on the August 5th agenda a resolution to support SB 805 and opposition to face masks, spoke on updating the City's website on legal rights as well as information on food donations and financial assistance, recognized Redemption Church for their work to assist those who need help, congratulated Battalion Chief Steve Airy on his promotion, requested to agendize the possibility of increasing business license fees and placing on the 2026 ballot, requested the ethics and code of conduct be brought back as soon as possible, and spoke on providing opportunities for participation and requested to end meetings earlier.

Council Member Reynolds spoke on the Caltrans agenda report and why she requested it to be moved to the August 5th agenda, highlighted on August 7th is an e-bike rodeo and workshop at Estancia High School, and on August 14th is a workshop by the Fair Housing Foundation, spoke on the Costa Mesa community being kind and caring to neighbors, spoke on the Mexican Repatriation and read a portion from the California Apology, spoke on racial profiling, due process rights, spoke on inhumane treatment and deaths to those who have been detained, spoke in support of Council Member Marr's requests, and providing legal aid, requested additional ways for people to participate in the meeting, and supports rental assistance and supports rental protections.

Council Member Pettis spoke on the July 3rd event, the Fairview Park plaque replacement, and spoke on the Arts Commission.

Council Member Buley thanked Police Chief LaPointe and Interim City Manager Gallardo-Daly for the opportunity to meet with law enforcement officers and the discussion on installing cameras on city owned buildings, spoke on meeting with Mr. Robbins on homeless issues, requested staff to research the licensing of sober living homes and the potential of paying the transient occupancy tax, and the importance of ensuring people are returned home once their insurance coverage at the sober living home ends, spoke on touring a Mesa Water facility, spoke on free speech and on a pathway to citizenship, finding a humane and compassionate way to address immigration, and expressed that SB 54 is counterintuitive and restricts communication.

Council Member Gameros spoke on free speech, spoke on people living in fear, stated that being an undocumented resident is not a crime, thanked Police Officer Dehuff for maintaining decorum, and spoke on the July 3rd event.

Mayor Pro Tem Chavez spoke on immigration, thanked the Costa Mesa Police Department for maintaining decorum, quoted "I'd rather die on my feet then die on my knees", expressed pride in his Mexican American heritage and the experience of growing up in Costa Mesa when being Mexican wasn't always accepted, spoke on people living in fear, and a decline of Latino participation, thanked everyone who spoke during public comments, spoke in support of discussing a resolution, spoke on SB 627, spoke on exploring options for legal aid and working with nonprofits, requested a Study Session for at fault evictions and for staff to start tracking the issue, and informed there is free lunch available for kids 18 and under at the library.

Mayor Stephens thanked everyone who spoke, thanked staff who helped with the July 3rd event, informed the Orange County Fair begins on July 18th, and on July 31st is the motorhome madness event, on July 30th he will participate in a race with other city mayors, spoke on attending the Mayors conference and meeting with Mike Johnston the Mayor of Denver and how Denver can serve as a model for protecting the Latino community, spoke on the First Amendment, read a statement that he and Mayor Pro Tem Chavez released, and spoke on the history of immigration in the United States.

In addition Council Member Reynolds spoke on the relevant issues for Costa Mesa: site management, fire concerns, fire prevention, access, vehicle volume and traffic concerns, access by walking and biking, wayfinding signage, shuttle drop offs, transportation connections, collaborations with other government agencies and tribal organizations, and grants.

Cynthia McDonald, Costa Mesa, spoke in support of the information provided to the public, spoke on the burrowing owls being discovered by Cindy Black.
