Dear Members of the City Council, City Manager Farrell Harrison and Director Sethuraman:

As you may recall, we sent you <u>a letter last year setting out our goals for Costa Mesa in 2024</u>. Today, we write to congratulate the city on the significant progress it has made to make our streets better for everyone, while also setting out new goals for 2025.

City Accomplishments in 2024

We were very excited to see the city take on a number of specific projects and reforms that have made a meaningful difference. These include:

- Lowering speed limits on 30+ street segments, implementing AB 43
- Installing leading pedestrian intervals at intersections throughout the city
- Closing the bike lane gap in front of Kaiser Elementary School
- Extending the Santa Ana Avenue bike lane south of E. 17th Street
- Making several bad intersections into four-way stops (California, Ogle, E. 18th, etc.)
- Launching Let's Go Costa Mesa and the GOAT
- Planning for the Safe Routes to School Action Plan
- Securing a \$305,000 CMPD grant to increase traffic safety
- Securing a \$400,000 Federal grant to hold pedestrian safety festivals
- Reforming the city's bicycle ordinances to address increased e-bike usage
- Hosting several bike rodeos throughout the city to educate riders on traffic safety
- Planting new trees and installed white bollards on Placentia bike lanes
- Organizing successful Walk- and Bike-to-School days
- Hosting Costa Mesa Grand Prix (Majestic Cycling) and earning a "bike-friendly city" moniker from the Daily Pilot
- Refurbishing many bus shelters and issuing an RFP for a new bus shelter contract
- Progressing plans for the Adams Avenue and Fairview Road projects
- Installing many bicycle racks in the public right-of-way and at city parks and facilities

Congratulations to the City Council, City Manager Lori Ann Farrell Harrison, Public Works Director Raja Sethuraman, Chief of Police Ron Lawrence and their teams for these wonderful accomplishments, and thank you for working so hard to make Costa Mesa a safer, more pleasant, and more delightful place to walk, roll, scoot, bicycle, ride and drive.

Goals in 2025

That said, the work of making our streets better is never done. Here's what we hope the city will enact this year:

- 1. Leverage our Pedestrian Opportunity Zones (POZs). The Circulation Element states that POZs are "areas where the City will pursue street enhancements to create pedestrian-friendly environments." We urge the city to take this statement seriously. Therefore, we call on the city to disfavor car-oriented uses such as new drive-throughs and gas stations in POZs, which work against the city's mobility goals. We also urge the city to identify intersections in the POZs to prohibit right-turns-on-red and, where possible, yield left turns. Unaddressed, these traffic patterns allow those on foot or bike to get hit from three different directions while legally crossing at a signalized crosswalk. Further, studies suggest that up to half of drivers turning right do not even look for pedestrians or bicyclists, making these changes critical in the POZs.
- 2. Implement AB 413 (Daylighting). This state law went into effect on January 1, 2024 and prohibits the stopping, standing, or parking of a vehicle within 20 feet of the vehicle-approach side of a marked or unmarked crosswalk, whether or not the curb is painted red. We recommend that the city conduct outreach to drivers regarding this new law (see what Oxnard and San Rafael did), and select locations to implement physical barriers like bike racks or striping with fixed traffic delineator posts which will then further discourage fast-moving right-turn pockets.
- 3. Work to increase staffing and retention at CMPD to... We are particularly concerned that the CMPD has disbanded its DUI unit due to staffing issues. We call on the City Manager to work with the CMPD to ensure this critical unit is reinstated as soon as possible. Additionally, so long as we solely rely on a high-attrition body of sworn law enforcement officers to handle our city's moving violations, we are going to struggle to enforce run-of-the-mill traffic laws. We encourage the city to innovate with respect to traffic enforcement, including considering the use of non-sworn personnel to issue low-level traffic and parking citations and to free up sworn officers for more critical tasks.
- 4. ... more effectively enforce traffic and parking laws. This includes cars blocking traffic (queuing drive-throughs, for example), cars blocking bike lanes (queuing school dropoff/pickup lines, for example), violations of the parking permit program, reckless driving, speeding, and red-light running. Additionally, we ask that the city reconsider its stance on force multipliers like red light and speeding cameras, which we think would produce equally dramatic and positive results.
- 5. Adopt modern and innovative land-use and parking policies. We urge the city to develop a more liveable Costa Mesa through smart land-use policy changes, including: activating the public right-of-way by orienting doors and windows to the street; removing unscientific, government-mandated parking requirements; eliminating FAR; easing DU/A

and setback limitations; auditing the parking permit program to ensure it can address legitimate parking overflow concerns; adopting innovative development rules, such as tying traffic impact fees to the number of provided parking spaces or requiring the unbundling of parking from for-rent units; and implementing paid street parking in appropriate commercial areas, like Randolph Ave and Permian Way.

- 6. Move to phase 2 for protected bike lanes. The city has done a great job of creating new Class IV separated bike lanes using K72 bollards as protection for cyclists. We believe that it's now time for the city to move to these bike lanes to the next phase, following the lead of cities like Santa Ana, Irvine, and Long Beach, and lay the groundwork to convert them to concrete-protected bike lanes. Long Beach, for example, has gone further and adopted a straight-to-permanent approach because doing so is more cost-effective than continuously replacing bollards. We challenge the city to figure out how we can reflect our city's commitment to active transportation and vibrant public spaces through more permanent and visually appealing design.
- 7. Utilize the Major Accident Investigations Team to analyze street infrastructure. When major collisions happen or when people are seriously hurt or killed on our streets, all factors contributing to these events should be analyzed. We call on the city to expand the mandate of the Major Accident Investigations Team to include an examination of the infrastructure factors involved in a collision in addition to the primary cause of the crash. This analysis should include a formal report of these findings to the Public Works Department and the City Council. Not only will being proactive about high-profile incidents show that the city is responsive, but it will also insulate the city from negligence claims by instilling a culture of constant evaluation and improvement.

Once again, the city made great strides in improving our streets in 2024. We look forward to continued progress in 2025 and beyond.

I am an owner/partner in two businesses in the Vista Shopping Center.

I object to the approval of the conditional use permit for the Westend Bar.

The removal of parking spaces will leave only one parking space for the business. Because the Westend Bar will provide no parking, you are assuming free access to the parking lot of the Vista Shopping Center across 19th Street by the patrons of the bar with no permission of the owners of this private property. The parking lot of Vista Shopping Center is for the CUSTOMERS of the businesses in the Vista Center. It is not a public parking lot.

In November I inspected the Vista Center Property. I watched for a 30 minute period. I observed 5 cars and 8 people park in the Vista Center lot and jaywalk across 19th Street, ignoring the signs prohibiting non-customer parking. They all walked into the Westend bar.

To approve this conditional use permit without addressing the parking and the unauthorized use of the Vista Parking lot by the patrons of the Westend Bar will cost us expenses we should not have to bear. Increased liability insurance costs, increased parking lot security costs to prevent unauthorized and misuse of the privately owned Vista Parking lot. There will be bad neighborhood feelings when non-customer cars are towed. I repeat. The owners of the Vista Center have not given any permission or authorization for use of our parking lot by the patrons of the Westend Bar.

I urge you to reject this conditional use permit until the Westend Bar solves its own parking problem by providing its own parking facilities within 100-200 feet of their business.
