

## "Tradiciones"

The mural at the Costa Mesa Gonzales Northgate Market will inspire locals and guests alike with a modern approach to an art form deeply rooted in Mexico. It tells a regal story that is centered around the Mexican American experience. The experiences of our parents and the dreams of our children can be seen dancing in gold.

The canvas consists primarily of Cochineal Red (a deep red), which is a color derived harvested from insects that live on cacti throughout Mexico and the South West. Harvesting the red dye is a pre-colonial tradition dating back centuries.

Sprinkled throughout the red field are gold (yellow) icons and figures. Tools, food, and nature are whimsically depicted in a way that invites the viewer into the painting and as well as the store.
