# CC-8 Marathon

 This is an annual event that Council approves each year; looks like council has to approve each year because segments of the route are not pre-approved – any reason not to update the existing resolution (04-38) to include these routes? Is it typical to have a city council give approvals for special events requiring street closures? Seems to me we should just weigh in if there would be a city cost impact.

Yes, this is an annual event and City Council has to approve as this is not in the pre-approved list of closures. While it may be efficient to update the existing resolution to include these routes, it will preclude Council's ability to require any changes if a need arises. In addition due to the extent of closures, bringing this to Council attention will also provide the Council and the community an opportunity to provide input on any concerns they may have.

• Looking more closely at our street closure policy (attachment 7) – I don't see anywhere south of the Fairgrounds included. What does that mean for street closures near Lions Park (e.g., for a future Fish Fry parade). Does that just mean that would require city council approval?

If there is need for full street closures in areas outside of the policy, we will have to secure Council approval. This is to provide opportunity for community to provide input on any proposed closure(s) and for staff to prepare required traffic control plans and notifications.

### CC-9

Did we consider a non-diesel option? Is there a portable LED tower with battery – if we have never tried one, can we try in a couple places instead of purchasing 21 diesel towers?
 Staff researched various units, including solar and electric, and determined that the Allmand GR Series Light Towers is the best and most cost effective option for replacement at this time. This model also upgrades our light units to an AQMD/EPA Tier 4 certified clean burning engine.

#### NB-3

- My understanding is that this project does not include the existing fire station building (e.g., living quarters and existing training room) please confirm.
  - Yes, the project is only for Training Tower and associated improvements. Improvements to Fire Station Living Quarters and training room within the fire station building are not part of this project.
- Looks like project scope includes the area up to the main access gate. We walked this area with the SafeTREC team regarding a better entrance/exit to the Joann St trail from the north. Can we include that consideration in the project design?
  - Modifying the Joann Street trail path is a different project that needs to be programmed and requires a consultant with expertise in traffic design. Please note that the improvements proposed as part of this project does not preclude implementation of SafeTREK recommendations in future.
