My Name is Rick Foster. I am a 50+ year resident of Costa Mesa. I have 7 children and 13 grandchildren. 5 of our children are biological and 2 are adopted from the OC social services agency. The first 5 are adults.

The last 2 adopted boys are 11 and 14. They both play tennis and the 14 year old is developing into an excellent player and will join his high school team in the fall as a freshman. I was a varsity high school and college tennis player. I am a US Army combat veteran.

We love Costa Mesa. 3 of our adult children live in Costa Mesa with grandchildren. We use our city's park and recreation facilities on a regular basis, often daily. Our son plays tennis in a coached clinic 3 times a week at the CM Tennis Center. He plays 6 times a week throughout the year. The facility is very good and the long standing staff of coaches and managers are very good and should not be changed. The City may not realize that this facility as it stands today is one of the only hard court, with 12 courts, dedicated tennis facilities in all of southern California. Most public and private tennis facilities have changed some or all courts to pickle ball. This makes it hard to find open tennis courts. In addition, you may not realize that NMUSD has closed all of the public school tennis courts (with the exception of Newport Harbor) at all high school campuses for public use other than by the on-site coach. OCC's new courts are also locked away from public use. These are blows to court availability. Private clubs such as MVCC are converting courts to pickle ball. Los Caballeros Racket and Swim Club in Fountain Valley has already converted half of their 24 courts, and has published plans to convert 100% in the near future, to permanent pickle ball. Where are all the tennis players to go?

We implore Costs Mesa to adopt a plan to keep the facility 100% tennis and to keep the current management team that has provided professional services to the local community for over 20 years. Our community facilities are intended to be of the community, for the community, and by the community. The professional members of the current and past management team have become thoroughly integrated into our tennis and social community in Newport Mesa and have more than earned the right to have their investment protected moving forward. Bringing in any outside management team not only makes no sense and will not only disrupt and terminate a decades long investment by Top Seed Tennis but will also disrupt the ongoing dedicated community of citizen tennis lovers, including members of my family and many other families that we have gotten to know at the Tennis Center.

Who among you in City Hall has visited the Tennis center early in the day, at any time during the day, or at the end of the day to witness the large amount of happy customers using this facility? Have you ever tried to interview any of the thousands of customers concerning the center's current status or future? If you did you could meet families that have moved from other centers in Tustin, or Newport, or other sites to Costa Mesa because of the polite, professional and dedicated staff at CMTC.

Have you even from your office computer or home computer searched for customer reviews of Agape or Top Seed or the CM Tennis Center. 50% of the Agape Fountain Valley reviews are terrible. Not of the facility, even though it has a poor reputation itself, but of the Agape staff and how the facility is run. Short hours of operation, few if anyone to answer the phone, impolite/unprofessional staff per customers comments.

90% of the CM Tennis Center's reviews, under which falls Top Seed's reviews, are overwhelmingly positive. That discovery alone tells us that giving the centers future to Agape is a very big mistake.

It has taken the City far too long to engage in a decision on the management contract and future of the jewel of a tennis facility. Stop the decision now or renew Top Seed for 5 years or maybe 10 immediately.

Invest in the facility and the current management team driven by the success of the current site and its customers. You plan to expand the local skate park but not the tennis park. Which one is more valuable to the community and which one is used by more community members? Upgrade the lights. Make some improvements as recommended by Top Seed

and customers alike. Even think about expansion. There is room for expansion. Make Costa Mesa a true center for professional and amateur tennis. Push back the tide of pickle ball to allow tennis to flourish. There are so many local pickle ball courts already in the area, including at Agape FV, that more are unneeded.

Mater Dei High School is ranked as the number 1 public or private athletic high school in California. They are ranked nationally and know internationally. They need a tennis facility as they do not have courts of their own. They have contracted with Los Caballeros for very long time but that relationship is failing to pickle ball. They would consider using the CMTC as their home courts and pay a handsome annual fee for the ability to train and play here. They won the CIF Southern California girls tennis championship in 2022. Wouldn't be great to have them hang their shingle on CMTC for the future of the facility and the City of Costa Mesa. Calvary Chapel HS is currently using CMTC as their home courts. Costa Mesa HS may also need courts as their courts have physical problems. Who knows what the possibilities are if you support the tennis professionals that are Top Seed in their quest to continue to grow the sport here in Costa Mesa. More players, more USTA, UTR, ATP Tournaments, more High School teams, and so importantly more citizens that can call, talk to a real tennis person any time they are open, book a court, book a lesson, play a match and celebrate the great City of Costa Mesa for its vision and commitment to one of the great sports of the world, TENNIS, and the great people of Top Seed and the local community citizen members.

My name is Chris Ketcham, and I'm the head men's and women's tennis coach at Orange Coast College. I'm writing in support of Syd Ball, Carsten Ball, Cameron Ball, and the current staff at the Costa Mesa Tennis Center.

In support of the Ball family and CMTC, it really starts with Hank and Maureen Lloyd running the center for 25 years with the Ball family being involved with the center in different capacities throughout that 25 years. The Lloyd's and Ball's are tennis royalty in Southern California who are great tennis ambassadors through playing, coaching, management, and promoting the game.

However, most importantly, they are honest, responsible, and trustworthy people who grew up in the Newport Mesa area so their focus is on building relationships and the success of the people in their community.

In the fall, I'll be starting my 17th year coaching tennis at OCC, and like the Ball's, I have grown up in Newport Mesa. Through those years, I have developed a great relationship with the CMTC. 

Good morning -

I have a Public Comment on Agenda Item #1 of New Business - the Costa Mesa Tennis Center (CMTC) item and am requesting that my comments be read into the public record.

I have been playing tennis at CMTC since appx 2016, taking lessons and playing on Sundowners and USTA teams representing CMTC. I used to play at Fountain Valley Tennis Center three times a week, and on USTA teams for the three years, prior to the takeover by Agape. Fountain Valley was a community tennis center, run by experienced tennis pros. Once Agape took over, the court conditions quickly deteriorated. Broken glass remained on the court for multiple weeks and the courts were dirty. When our team was hosting a USTA match, we arrived to find debris on the courts and the same broken glass. When I approached the staff, they did not appear to understand the significance of this and couldn't assist, as they were holding a clinic. In addition, they have double striped all tennis courts with additional junior tennis lines, making the courts undesirable for USTA matches. Our weekly group of 12-20 people moved to Cabrillo Tennis Center, and have not returned. Courts that were once full during the week, now have many empty courts.

We have now learned that the City Manager intends to award the management of the CMTC to Agape. I am not sure what promises they have made to the City Manager, but I cannot believe the City Council would choose to award this contract to an organization from Georgia, and not at least allow the Ball Family an opportunity to manage the tennis center. The Ball Family are community members and have been a part of CMTC for more years than I have been playing. Since Hank and Maureen Lloyd's retirement, they have done a fantastic job running the center, and have the full support of those that play at CMTC. The facility is clean, the staff are friendly and welcoming. They have quality tennis pros and offer clinics and lessons for beginners to high level players. Having been involved for so many years, they know what is important to this community.

I understand it is the intent of Agape to convert most, if not all, of the courts to pickleball. CMTC holds many junior and college level tournaments for our up and coming youth. Due to the court elimination of tennis courts at FVTC and the double striping, those courts are no longer usable by some of the high level tennis tournaments for our youth. Where are these young players supposed to develop their game? There are many talented youth that do not have the means to join private country clubs. It would be a shame to strip the local and surrounding communities of the youth tennis programs so many enjoy.

I sincerely request that the City Council reject any motion to award the management of the CMTC to Agape.

Dear City Council Members:

I've read the Agenda Report for this Item and have concerns and questions. Can you please request that Staff answer the following questions at tonight's meeting:

There is a great deal of focus in the Agenda Report on converting all or a portion of the Costa Mesa Tennis Center ("CMTC") to a pickleball facility. Was that done at the direction of the City Manager or one or more City Council members? And if so, who did it and why? Was it the result of the online survey that the City did? How much of this came from the desires of the residents? Was an effort made to obtain surveys from the current users of the CMTC other than the online survey?

In the analysis section of the Agenda Report it states that the panelists reviewed all the proposals and evaluated them based on "Qualifications of the Proposer/Organization and Key Personnel." What was the criteria used in evaluating these qualifications and what was the weighting of the scores?

The applicants were also evaluated based on providing the scope of services. Please provide the requested scope of services and the weighting of the scores.

Applicants were also scored based on qualifications and experience. Please provide more information in terms of the criteria used for both qualifications and experience. For example, what are the background and experience of the personnel that would be providing the services? How was that ranked? Was the scoring higher for applicants that have instructors who have played at higher levels? Was this weighted higher than other criteria?

On Page 4 there is a statement "Agape understands the City's objectives for operations. Does this mean that the other applicants did not understand the City's objectives? Why does Staff think this is? Also, please provide those objectives.

There is considerable space given in the Agenda Report that relates to public relations for Agape. Much of this, such as the cute "core values," seems irrelevant to the City's decision-making process and I do not know why it was included, other than to make a sales pitch to the public. Little information is given on Agape's ability to provide good service, which is the primary concern of the residents.

With respect to its social media content, please provide the backup for the statement that "Agape leads a successful social media outlet." In other words, how much of the social media content actually engages the public and brings clients to their centers? How many Instagram, Facebook and YouTube posts are there on a monthly basis and what is the hit and engagement rate?

Under "Tennis Center Operations," on page 4, how are Agape's operations different and better than what is provided now? Also, I note that they will accommodate walk-in players, but they do not do that now in Fountain Valley. Why does Staff think they will do it in Costa Mesa?

Will the pro shop offer more than just the Agape branded clothing? Their Fountain Valley location does not.

On page 5 in the list of concessions, who chose the products that will be for sale? Is there any consideration being given to the vermin problem that exists in TeWinkle park (I saw huge rat there on Walk to School Day last fall)? Also, what sort of "special events" are anticipated by the City? Have food trucks been something the CMTC clients have expressed a desire to have, or is this something Agape wants?

In terms of programs, did City Staff go and observe lessons at Agape's Fountain Valley, Camarillo or Oxnard locations and verify that it was currently providing those programs and competently doing so?

Under "Marketing and Hours of Operation," how does Agape plan to make the CMTC the "premiere tennis recreation destination in Orange County"? The City needs to make many capital improvements, so that ball seems to be in the City's court (pun intended).

Overall, it would be helpful if we had a matrix of the criteria used for making the decision and how it was weighted.

I believe that the CMTC is an amenity that needs to be provided to the residents and visitors to encourage people to be active and healthy. Additionally, I feel this asset of the City could provide more income to the City, so it is important to select the right operator that increases clientele but is open to imaginative use of the facility when it is not used for play.

On several levels, I'd be disappointed if you didn't select Top Seed. I've known Hank Lloyd for more than 40 years and value his knowledge in recommending an operator. I've known and taken lessons from the Ball family for at least 10 years and know first-hand the excellent instruction they give their clients. I've played at the CMTC since about 1973 and know its history. In the past 18 months since Hank's retirement, I haven't seen any detrimental action taken by the Balls and Top Seed. In fact, they have taken great care of the facilities, given what they have to work with.

If I thought Agape could fill the shoes of Hank Lloyd and/or the Balls, I would support Staff's decision. But I cannot. The problem with Agape is that my research tells me it has not been a good operator nor has it been a big money maker. Its closest operation, Fountain Valley, has fallen short of success in terms of income generated for that city. Looking at the City of Fountain Valley's budget, the anticipated revenue for fy22-23 for court fees was \$63,600, up from \$35,000 from the prior year. The current budget document does not show what the actual receipts were in fy22-23, but for fy23-24 the budget only shows a slight anticipated increase in receipts to \$66,000.

Comparing the budget in Fountain Valley to the actual receipts of the CMTC, in GL Month June 2022, court fees collected were \$75,313 and the pro shop generated \$5,017. In one month, that is more than Fountain Valley anticipates receiving in one year. Why would the City of Costa Mesa hire an operator who isn't generating a similar revenue in a nearby city with similar facilities?

Another consideration with Agape is how is it going to continue the goodwill established by the prior operator of CMTC. The community is already not trusting Agape because of its owner's and supporters' behavior at a prior City Council meeting and its desire to turn the center into a pickleball facility. The current instructors at CMTC have not indicated they wish to be employed by Agape. In fact, one has told me they have no interest. The current players will likely take their business elsewhere, particularly after taking one lesson from Agape.

I've visited and played on the Fountain Valley courts several times over the years, and recently went to observe individual play and lessons on two separate occasions on different days and times of day. My visits lasted anywhere from several hours to 45 minutes. What I saw were classes that were too full. Players were not given instructions on how to properly execute strokes. The courts were somewhat dusty and needed to be blown off, which created a safety issue because shoes are supposed to grip hard court surfaces. I observed one instructor admonishing a child on the court in front of all his classmates.

Costa Mesa's courts are always clean and ready for play when the facility is open. The instructors limit the number of students to a class in order to give the best lessons. The teaching is done in a style that recognizes that every person has a unique way of learning, so no one feels they aren't welcome on the courts. The focus is on building and improving skills. Every student is observed and if correction is needed, it is done immediately with instructions given on how to properly execute or improve the stroke. If an instructor has an issue with a client, they talk off the court in private.

Like all other sports, playing tennis isn't fun unless you win at least some of the time. The key to that is good instructors who give you the skills and confidence to hit the shots that are needed to score points. The instructors at the Fountain Valley Tennis Center don't have the same background and credibility as the instructors at Costa Mesa. They aren't people who have played and won grand slam tournaments. Many of the Fountain Valley instructors are young people who played on high school varsity teams, but that is far as they got, and they aren't pursuing tennis instruction as a career.

Since the owner of Agape lives on both sides of the country, she has delegated management of the locations to others. If she spends 50% of her time on each coast, and that gets divided between four West Coast locations, she will be spending approximately 16.66% of her time devoted to Costa Mesa. Tennis centers need full-time, hands-on management. The inferior quality of instruction and management at Fountain Valley is proof that Agape is simply not a good business model.

With respect to adding pickleball to the CMTC, pickleball is a completely different sport than tennis. It requires considerably less body movement; thus it is easier in terms of cardio and joint stress. It isn't new. It has been played for years and has been in and out of fashion, similar to racquetball. Find the YouTube of Huell Howser's California Gold 2005 episode about it being played in Venice and watch it. Tennis, on the other hand, has lasted in popularity for hundreds of years, and generates billions of dollars in revenue each year.

Pickleball is currently played in Tanager Park and at the Downtown Recreation Center. We don't need to destroy the CMTC by making pickleball the primary sport played there simply because it is the "in" sport at the moment. I note that Agape converted one of its facilities in Camarillo entirely to pickleball. I'm not against taking a couple of courts in the back and making them temporary pickleball courts, but careful consideration should be given to any large capital improvements for a fad that very well could be passe in a few years.

In summary, I do not support Staff's recommendation for selecting Agape and the operator. Please reject the recommendation and request that Staff reassess its decision, both based on my research (they may want to contact Oxnard and Camarillo about revenues as those cities do not post the numbers in their budgets) and the overwhelming negative response by the residents and community to this recommendation.

I was made aware of the decision the City Council of Costa Mesa to vote tomorrow 07/18/23 on the fate of the long term contract to run Costa Mesa Tennis Center. I was also made aware that you are favoring a competing group, Agape, to replace the current group Top Seed Tennis.

I am extremely concerned and upset over the City's handling of this matter.

In typical fashion, the decision comes unannounced and seems without consideration of the preference of the ACTUAL LONG TERM PATRONS of the Costa Mesa Tennis Center, of which I am one.

> I have played tennis in Orange County for years and have extensively used the facilities of both the Costa Mesa Tennis Center and the Fountain Valley Tennis Center. Upon he retirement of Hank and Maureen Lloyd, the current operators made many positive improvements to the Costa Mesa Tennis Center including the appearance and cleanliness of the restrooms and the office area that were well received by all who play there. Adversely, when Agape took over the Fountain Valley Tennis Center, many changes were made that negatively impacted the quality of that facility. The courts are frequently dirty with trash not being cleaned up. For several week in a row, there was broken glass on one of the courts from a light fixture that was never swept up. From the staff report:

"Thereafter, the City can apply to continue funding in Round Two, however, at this time there are no funds set aside for Round Two. If no other funding source were available, the City's General Fund contribution would grow by at least \$2.2 million, assuming contracts increase 3% per year, for an estimated total of \$4.0 million for the City's Bridge Shelter Program. Based on the City of Costa Mesa's financial outlook of the General Fund, it is unknown at this time if there would be sufficient available funds to cover this cost, among other fixed cost increases.

Finally, the legislation language specifically states that the construction must be finalized within one year of the contract approval date. Since this stringent construction schedule is not feasible, the City could risk the \$3.8 million in grant funds for any construction costs expended. While we have received assurances that this is not likely the case, we have not been able to secure such a commitment in writing; hence the precaution."

Please accept my comments for #9 on the Consent Calendar Item#23-1291, Titled: 2021 and 2022 Annual Review of the Costa Mesa 2015-2035 General Plan

I understand that all the elements of a General Plan affect each other. In my opinion, they should fit together into a good comprehensive whole where they all support each other.

Focusing on just 3 of the elements: **Conservation Element, Open Space and Recreation Element, and Historical and Cultural Resources Element, I** have some concerns and questions about what is said in the General Plan and what city council is doing.

The Conservation Element **Goal CON-1:** "Preserved and Restored Natural Coastal Habitat and Landforms. It continues to say that, "It is the goal of the City of Costa Mesa to provide residents with high-quality environment through the conservation of resources, including land, water, wildlife, and vegetation, and the protection of areas of unique natural beauty. (2000 GP Goal CON-1)"

The City has failed in this goal when city council directed city staff at the May 2, 2023 city council meeting to allow glider planes to fly in Fairview Park. Fairview Park is the only nature park in Costa Mesa with endangered plants and animals and the city council went against ALL recommendations by USFW, CDFW, city staff, city committee, and the community when they ordered city staff to allow this in Fairview Park. Many creatures rely on the soil for their survival such as Sweat Bees and it was negligent by city council to allow HSS to remove native plants and scrape the ground. This kind of irrational decision to allow this destruction of a unique ecosystem, does NOT fulfill the Conservation Element Goal and Objectives and has negatively affected the whole community.

The Open Space and Recreation Element Goal and Objective NOT met by city council in their May 2, 2023 order to allow glider planes to fly in Fairview Park.

The OSR – Goal and Objective is to have a "Balanced and Accessible System of Parks and Open Space" and Provide a high-quality environment through the

development of recreation resources and preservation of open space that meets community needs in Costa Mesa. (2000 GP Objective OSR -1A)

The destruction of native plants for a private group's hobby that does NOT serve the whole community is stealing park space from the community and not preserving the open space. Costa Mesa is supposed to have 4.26 acres of open space per 1,000 residents. In 2015, Costa Mesa was under 3 acres. This taking away of open space and not preserving it has failed the goal and objective of this element and negatively affects the whole community.

The Historical and Cultural Resources Element was also negatively impacted by the city council's May 2, 2023 order to allow glider planes in Fairview Park. Fairview Park is home to two core archaeological sites: ORA-58, and ORA-506.

ORA-58 is located on the west side of Fairview Park and any good steward of the park would know that disturbance to the ground should be closely monitored by an archaeologist, paleontologist, or authorized Native American. Artifacts have been found near the end of Pacific Ave. when the city wanted to dig there in 2015.

The city council ordering city staff to have glider planes in Fairview Park resulted in the Harbor Soaring Society not only taking out native plants that took a few years to recover, but they were scraping the ground too. This type of altering to a natural environment home to a near-by core archaeologist by a bunch of hobbyists is NOT fulfilling the Historical and Cultural Resources goal and objectives.

City Council has disappointed many people in the community regarding their May 2, 2023. One resident took it upon himself to start a petition on the day of destruction by HSS in Fairview Park, July 15, 2023. This petition on Change.org has already 295 signatures. The community is outraged by city council's disregard for Fairview Park's plants and animals. The City Council has stopped the city from meeting these goals and objectives for 2023.

This is a response to the many inaccuracies put forth by the Harbor Soaring Society (HSS) in their May 2, 2023 written comments submitted to City Council and comments referencing it by president of the harbor soaring society, Mr. Mat Garcia.

HSS first paragraph says that the HSS "recommends implementation of the actions City Council approved at the September 21, 2021 meeting" and "Absent any new substantive, empirical data or analyses from regulatory agencies or independent, authoritative sources, we believe it is appropriate to proceed with the City Council's approved actions. No such information has been provided in the latest staff report." FICTION

FACT: California Department of Wildlife (CDFW) provided their recommendation to city staff in an email dated March 20, 2023 from their Senior Environmental Specialist Supervisor stating their "SUPPORT FOR FULL CLOSURE OF THE FLYING FIELD DUE TO IMPACTS TO SENSITIVE BIOLOGICAL RESOURCES." . This email came two years after the September 21, 2021 city council motion and is new substantive information from an authoritative source.

HSS says that model glider flyer is "recognized in the Public Use Objectives of the current Fairview Park Master Plan and indeed is included in the third defined objective of the plan: Provide for continuation of the organized uses that have historically occurred on the site, including model railroading, model airplane, and model glider flying. (Pg. 27) The plan presents a park for passive uses, including walking, jogging, biking and quiet contemplation, and includes a model railroad, glider and kite flying, and group picnicking all offered without compromising the overall passive nature of the plan. (Pg. 28) FICTION

FACT: HSS failed to provide the entire paragraph leading up to 'Public Use Objectives' (FPMP p. 28) Which says,"The natural setting will dominate and provide the opportunity for walking, jogging, biking, and quiet contemplation." There are many uses proposed in the Fairview Park Master Plan that DO NOT align with this goal and the FPMP recognizes that with each successive update, proposed uses will be taken out due to their incompatibility with the natural resources. "The plans involved a range of activities gradually moving to more passive uses in each successive plan." (FPMP p.8) Under 5. Design Objectives in the FPMP it says," The overwhelming consensus is to continue a park for passive uses by individuals and small groups and to enhance the natural environment of the park for those uses and as a habitat preserve." (FPMP p.25) The many uses that have been deleted in FPMP updates include a play area, dog park, botanical garden, bus turnaround, parking lot, group picnic site, and more.

HSS claims on page 2 of their comments, "The flying of glider aircraft is specifically noted as an activity "compatible with the natural habitat restoration and archaeological preservation to occur in the major portion of the site" within the Fairview Park Master Plan on several occasions. FICTION

FACT: What HSS claims is simply not there in the FPMP and that is probably why they don't put any page numbers to reference their false information.

What is in the FPMP is,

"However, the overall policy direction for passive, natural preservation and restoration is to guide all detail development actions." (FPMP p.28)

HSS continues in their comments to compare their flying to the model railroad use but what HSS fails to recognize is that the model railroad is providing the public with an opportunity to get close to the natural resources in Fairview Park without trampling or negatively impacting them. The railroad can only go where the tracks have been laid. The glider planes are unpredictable. There are numerous accounts of glider planes going in vernal pools, crashing and burning in sensitive habitat, threatening public safety, injuring residents, threatening police helicopters, using weed killer in sensitive areas, actually hitting birds, and much more. Through all this, HSS likes that the city has been "lenient". (see attached HSS Newletters zip file) HSS poses a conflict unlike the model railroad does.

HSS continues on pg. 3 of their comments to talk about Measure AA and says, "Clearly, closing the flying field is an alteration that reduces benefits to the public and changes the 'As Built' condition of the park. An option that includes modifications to the use, and/or movement of the field will have consequences from Measure AA, potentially including the requirement of a full vote of the public to be implemented." FICTION

FACT: There is no 'fly field' in the FPMP so there is no modification or alteration to Measure AA by keeping the 'fly field' closed. It is a vernal pool watershed. HSS seems to know this because proposing a vote of the public wouldn't be talked about unless HSS knew that there was no 'fly field' in the FPMP in the first place.

HSS comments continue to say that all recommendations by CDFW as well as the comprehensive evaluation that city staff spent over a year and a half doing should be disregarded. The verbal attacks on CDFW, and city staff not showing 'good faith' is not based on any evidence. HSS saying the city contracted biologist cannot be listened to because he works for the city is unreasonable and unwarranted. The community feels that city council should listen to environmental experts, city staff, city committee, and the community and NOT

a small group of flyers who push for their degrading hobby and are not environmentalist experts?

The HSS president, Mr. Garcia, told city council at the May 2, 2023 city council meeting, that city staff was the only ones against flying in Fairview Park. FICTION

FACT: That is simply not true and there is much evidence to support that it is not true. The city committee, the Fairview Park Steering Committee, of which Mr. Garcia is a member of, also voted against any flying in Fairview Park because not only of the environmental degradation it would cause but also because of the public safety and enforcement issues. Wouldn't Mr. Garcia know what the committee voted on since he is a part of it? Why would he say that only city staff was against flying in Fairview Park? Does he not have a memory? Is he intentionally spreading misinformation? What other reason could there be?

I have been a Fountain Valley resident for over 40 years. Having played and experienced various tennis programs around the OC region for the past 25, namely, Fountain Valley, Huntington Beach, Fullerton, Anaheim, Mission Viejo/Laguna Niguel, and Costa Mesa. I have gone even as far as Long Beach and Seal Beach.

Based on what I have experienced, the coaches and folks managing CM is probably the "best-balanced", meaning meeting the city's needs as well as the community's (players). It is not far-fetched to say that CM, formerly run by Hank Lloyd and now with Top Seed, continues to be the most popular tennis courts of choice by the players/patrons. I have seen the downfall of the H.B. program (now by Tennis Anyone), and I used to play at Mile Square Park under the prior management there UNTIL Agape took over.

Now I do not go to Mile Square to play tennis because the courts are filthy, crawling with ants, and visible of constant debris on the courts. The reservation system is a joke as no one ever answers the phone and reservations are difficult to make. I was willing to drive 20 minutes farther to play at CMTC with Hank, the Ball family, Eduardo, Patrick because they know how to treat their customers.

The group of players who play at CMTC come from not just C.M. or the surrounding cities within O.C. – we have players coming from as far as Rancho Cucamonga and Riverside on a weekly basis – and everyone gets along – this is a culture that no single outside operator can replicate, especially if the players start to leave because the coaches leave due to management change.

I am a lost as to why would any city government would risk losing these coaches or the players – since players FOLLOW coaches, not city or outside ownership – just because the city THINKS someone will offer a better deal?

Is it about the money? Is CM City Council ready to bear the consequence of another poor decision like H.B. and F.V. just to make a few extra bucks without considering the negative impacts of losing coaches or unhappy players just to please a select few for the trendy pickleball wave? I hope this letter finds you well. I am writing to express my deep concern over the recent awarding of the management contract for the Costa Mesa Tennis Center (CMTC) to Agape Tennis Group. This is my SECOND letter because more information has come out regarding the details surrounding the decision to award the contract which was was made exclusively by City Manager, Lori Ann Farrell, raising questions about transparency and fairness in the process.

- 7. Claims that Agape will introduce pickleball to CMTC while implying that the McAvoy/Ball team will not, need to be carefully assessed for accuracy. Ensuring fair representation of facts is vital in such matters.
- 8. I urge you, as dedicated Council members, to closely examine the decision-making process and ensure that personal preferences do not supersede the best interests of the community. Replacing a legacy with another entity solely based on personal preference could undermine the stability and progress of CMTC.

In conclusion, I implore you to thoroughly investigate the circumstances surrounding the awarding of the management contract and to uphold the principles of transparency, fairness, and inclusivity that our community values. By doing so, we can ensure that CMTC continues to thrive and serve the needs of all residents.

This email is in support of Agape Tennis Academy. I was planning to show support in-person for this organization in its consideration with the Costa Mesa Tennis Center; however, my work interferes with the time of the meeting and will not be able to attend on time in-person.

However, I do want to confirm that Agape Tennis Academy is an amazing organization and academy, and despite me living all the way in Lakewood, I have consistently gone down 2-3 times every week to attend their clinics and classes. I definitely have tennis centers closer to me, but the community that Agape successfully builds and the care they implement at their facilities is top-notch, and if it is pulling me 30-50 minutes commute just to play tennis (even if there are courts 5 minutes away from me), they are clearly doing something right!

Since I do not have personal experience with the way that Top Seed runs the tennis center, I will not touch too much on that; however, I have been to the Costa Mesa tennis center a few times and talked to people who go to both Fountain Valley and Costa Mesa, and one thing is constant, the sense of building a community through clinics, coaching, and facilities seems to bring more players back to FV than it has at Costa Mesa.

Again, I am a way out over in Lakewood and simply frequent the areas of Irvine and Costa Mesa quite often and really only stop by Fountain Valley for tennis, so I believe I am unbiased in terms of cities/location, I just hope that amazing tennis centers continue to exist and am showing my support for Agape based on what I've experienced first-hand.
