Throughout my work in Congress and healthcare, I have been a strong advocate for vulnerable populations with a focus on housing and equity.

As a former senior congressional staffer and healthcare advocacy leader, I have worked closely with non-profit organizations, counties, and cities to secure federal and state funding.

During my congressional years, I tracked the development of local Consolidated Plans for medium and large cities within the congressional district, provided input on those plans, and coordinated with community-based organizations as they submitted CDBG grant proposals within those local jurisdictions.

During the pandemic, my healthcare advocacy team advocated to direct CDBG CARES Act grant dollars to address housing instability issues and supplement other state and federal funding programs to keep individuals and families housed. My advocacy team also coordinated closely with our community health investment leads to review and share community health needs assessments and action plans with key community partners.
