I would like to seek reappointment to the Planning Commission because I have a passion for public service and for applying my knowledge and experience to this decisionmaking process. I have direct experience of the role of Planning Commissioner from serving for fifteen months on the Planning Commission and would be honored to serve for a full term. I believe that I make a unique contribution to the Planning Commission as a young person who grew up in Costa Mesa. I also have a professional background which enables me to fulfil this role well.

Over the last fifteen months, I have gained the experience of having served on the Costa Mesa Planning Commission. In this time, I have reviewed a variety of applications and items, from the Housing Element and the city's new accessory dwelling unit (ADU) policies to the city's first fourteen Measure Q retail cannabis applications, in addition to various business and residential conditional use permit (CUP) applications. My background in civil engineering has enabled me to apply an analytical approach to every planning commission item. I have performed my work with a balanced and holistic review method and have sought to consider every aspect of a proposed project in weighing the merits of each application I have reviewed. I have also sought to include the feedback of community members and other stakeholders who may be affected by proposed development projects. I have achieved this by visiting project sites and surrounding neighborhoods and businesses, as well as through having conversations with nearby residents and reaching out to neighboring businesses by phone, whether or not they have written in to give their public comments.

As such, I understand the challenges faced by families, young adults, and others seeking to make Costa Mesa their home but encountering difficulties, such as rising rent prices caused by gentrification and inflation, and the difficulty of purchasing a home in Costa Mesa because of the lack of affordable homes on the market. My experiences have allowed me to bring a unique perspective to the Planning Commission that has informed the decisions of my peers on the Commission, and has brought the challenges faced by renters, people with disabilities, the Latino community, owners of small businesses, and other disadvantaged residents of Costa Mesa to the forefront.

Furthermore, my full-time role as a Transportation Engineering Associate for the Los Angeles Dept. of Transportation in the Planning and Development Review division has provided me with ample relevant experience to serve effectively on the Planning Commission. Through this role, I have become very familiarized with the impact of planning decisions and policies on traffic circulation and on local communities. I am very knowledgeable with the latest design concepts that facilitate safer site circulation, as well as transportation demand management (TDM) measures that reduce vehicle dependency and encourage active transportation through project designs and programs.
