5. EXTENSION OF RESOLUTION NO. 2022-62 TO ALLOW MEMBERS OF THE CITY COUNCIL, COMMISSIONS AND COMMITTEES TO PARTICIPATE IN THE MEETINGS REMOTELY, AS NEEDED, DUE TO HEALTH AND SAFETY CONCERNS FOR THE MEMBERS AND THE PUBLIC PURSUANT TO ASSEMBLY BILL 361

ACTION:

City Council extended Resolution 2022-62 to allow the members of the City Council, Commission, and Committees to participate in the meetings remotely, <u>as needed</u>, via Zoom due to:

- The current State of Emergency and global pandemic, which continues to directly impact the ability of the members of the City's legislative bodies to meet safely in person; and
- Federal, State and/or local officials continue to impose or recommend measures to promote social distancing.

6. ACCEPTANCE OF RANDOLPH AVENUE AND ST. CLAIR STREET PARKING AND PEDESTRIAN IMPROVEMENT PROJECT, CITY PROJECT NO. 21-07

ACTION:

- City Council accepted the work performed by All American Asphalt, Inc., 400 East Sixth Street, Corona, CA 92879 for the Randolph Avenue and St. Clair Street Parking and Pedestrian Improvement Project, City Project No. 21-07, and authorized the City Clerk to file the Notice of Completion.
- 2. Authorized the City Manager to release the retention monies thirty-five (35) days after the Notice of Completion filing date; release the Labor and Material Bond seven (7) months after the filing date; and release the Faithful Performance Bond one (1) year after the filing date.

7. MEASURE M2 EXPENDITURE REPORT

ACTION:

City Council adopted Resolution No. 2022-77, approving the Measure M2 Expenditure Report and authorizing staff to submit the report to the Orange County Transportation Authority (OCTA.)

8. CLEAN CALIFORNIA MAINTENANCE AGREEMENT

ACTION:

- 1. City Council approved the Clean California Maintenance Agreement between the City of Costa Mesa (City) and the California Department of Transportation (Caltrans).
- 2. Awarded a Maintenance Services Agreement (MSA) to The Sayler Group Corporation, 28699 Fieldgrass Street, Menifee, California 92584 in the not-to-exceed amount of \$150,000.
- 3. Authorized the revenue and expense appropriations in the amounts of \$150,000 respectively, for the maintenance agreement with Caltrans.
- 4. Authorized the City Manager and City Clerk to execute both agreements and future amendments within Council authorized limits.

9. ALLOCATION OF AMERICAN RESCUE PLAN ACT (ARPA) FUNDS FROM THE COUNTY OF ORANGE FOR CITY PROJECTS

ACTION:

- 1. City Council approved the projects for the allocation of American Rescue Plan Act (ARPA) funds from the County of Orange.
- Authorized the City Manager to negotiate agreements and appropriate eligible ARPA funds that were allocated to the County through the Office of Supervisor Foley for two City projects.

10. ADOPT A RESOLUTION FOR THE APPLICATION OF SPECIFIED GRANT FUNDS FROM THE STATE OF CALIFORNIA DEPARTMENT OF PARKS AND RECREATION

ACTION:

- 1. City Council adopted Resolution No. 2022-78 for the formal submittal of a grant application to the California Department of Parks and Recreation Specified Grant Program for \$10,000,000 in grant funds for improvements at the Jack Hammett Sports Complex, TeWinkle Park and Athletic Complex, Fairview Park, Shalimar Park; and \$1,200,000 in grant funds to expand and upgrade the Ketchum- Libolt Park (Grant-Funded Projects).
- 2. Delegated authority to the City Manager, or her designee, as the agent of the City, and under City Council direction, to accept grant funds, conduct all negotiations, and execute and submit all documents including, but not limited to, applications, agreements, deed restrictions, amendments, and payment requests which may be necessary for the completion of the upgrades at Grant-Funded Projects, in order to expend all funds by the statutory deadlines.
