3. NEW BUSINESS

a) REVIEW OF PROPOSED CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET FOR FISCAL YEAR 2022-23 THROUGH 2026-27 22-706 Mr. Sethuraman, Mr. Yang, and Mr. Ryan presented.

Vice Chair Dorn Parker mentioned two challenges: dogs in the park off leash and not a lot of infrastructures to support owners to clean up their pet's mess. Inquired if there is anything in the CIP to begin a launch of more specific signage at Parks to educate the public.

Commissioner Ashendorf inquired more about the Mesa Verde Library and ADA compliance improvements and if there can be more specific timelines.

Commissioner Andrade Vallarta thanked City staff and asked about the Shalimar Park expansion and if there can be more specifics to the amount of land that is being acquired. Also mentioned she is looking forward to improvements at her District parks and if there would be opportunity to evaluate space usage at parks to potentially repurpose spaces in a more engaging way for the public to maximize the space.

Commissioner Brown: Inquired about what staff's view for the CIP are. As in, if everything staff want represented in this report?

Commissioner Ashendorf is happy to see progress in current project and future ones, such as the Butterfly Garden. This is what we wanted. They didn't even have to ask me what was happening. But it was a good way to ensure that the community sees what's finally happening out there. So really wanted to share that. That's really exciting. Where the direction that this new department this new city we have is really going in a good strong, positive direction. And one other comment about the butterfly gardens.
