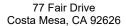

Steve S. – Requested review of protecting netting for foul balls at the TeWinkle Sports Complex.

COMMISSIONER COMMENTS

Commissioner Ashendorf: Appreciated the cooling center being available during the heat wave. Also appreciates the "How-To" signage at Tanager Park for pickleball play. Requested clarity for the Jordan Park ribbon cutting based on Councilmember Harlan's comment at Tuesday's Council meeting. Attended the ribbon cutting for the musical instruments at the Donald Dungan Library. Mentioned Costa Mesa residents, Dom Jones and Richard Kuo, who live on the East side and are competing in The Amazing Race, starting on September 21.

Commissioner Murphy: Thanked staff on finding storage space for the Newport Mesa girls' softball. Thanked staff for addressing the Dog Park issues. Looking forward to staff resolving the foul ball issues at TeWinkle Park.

Commissioner Andrade Vallarta: Appreciates all the hard work staff have placed in summer programs. Wanted to see if an enclosed facility would be available for future summer camps as well as enrichment activities. Suggested stem exposure while being off on school break to continue to accelerate their learning.

Commissioner Brown: With high community interest for pickleball courts and the installation of Tanager Park courts, which locations are next for court additions? How late are they to be open for? Enjoys the aesthetic look of the Spotlight and the organization of the layout.

Vice Chair Dorn Parker: Acknowledged the benefits of having the MyCostaMesa App and the responsiveness with staff to fix the conflict. The more community use, the stronger we will be to help resolve any items that need assistance. Requested staff to review drinking fountains and shading structure at parks. To help ensure the community is staying hydrated and not overheating during heat waves. Inquired on indoor facility use where they can meet at no charge or very little charge. RECOMMENDATION:

Staff recommends that the Parks and Community Services Commission deny the request to remove three (3) City owned trees growing in the public right-of-way on the Gannett Drive side of 1960 Swan Drive.

BACKGROUND:

The Maintenance Services Division was contacted by the applicant on March 27, 2022, requesting the removal of the trees growing in the public right-of-way on the Gannett Drive side of 1960 Swan Drive (Attachment 1). The applicant cited an excessive amount of pine needle drop, which was dropping in the applicant's pool causing issues with the filtration equipment. The applicant also stated the roots from the tree were causing sidewalk lifts and had damaged a private drain from the backyard to the gutter.

Four work orders were identified relating to the subject trees (Attachment 2):

- August 27, 2012 Maintenance Services received a report that the sidewalk had sunken 2".
 Maintenance staff placed one (1) asphalt ramp.
- March 16, 2015 Maintenance Services received a request to remove a pine tree on the Gannett Drive side of the property. The arborist contacted the resident and it was agreed that the trees would be trimmed. The trees were trimmed on June 12, 2015.
- May 10, 2018 Maintenance Services received a request to trim the trees on the Gannett Drive side of the property. The trees were trimmed on June 5, 2018.
- March 15, 2021 Maintenance Services received a request to remove the pine tree closest to their pool on the Gannett Drive side of the property. The arborist evaluated all three (3) trees and determined that there was no justification for removal. The resident was informed of the findings.

The sidewalk, adjacent to the trees on Gannett Drive, was replaced in July 2020 as part of the

Citywide Parkway Project #18-16.

The arborist evaluated the trees and the surrounding area on April 22, 2022 and determined that there was no justification for the removal of the trees at staff level. The applicant's request for removal was denied. The applicant requested that the removal be brought forward for the Commission's consideration as a Category 3 - Discretionary Removals, according to the Streetscape and Median Development Standards (Attachment 3).

ANALYSIS:

The three (3) trees being requested for removal are Canary Island Pine trees growing in the public right-of-way on the Gannett Drive side of the property. The trees are approximately forty-five to sixty feet (45-60') in height. They are healthy and in good condition; and were last trimmed by West Coast Arborists on June 5, 2018.

The amount of pine needle drop beneath the trees and in the surrounding area appeared to be normal at the time of inspection. The shedding of pine needles is a natural part of the growth process for healthy pine trees.

The sidewalk adjacent to the trees have been ground previously due to lifting caused by the roots of the tree. The repairs are holding; and do not appear to be creating a significant exposure to liability for the City.

The pine trees do not meet removal criteria as a Category 1 - Health and Safety Removal. The trees are not dead, diseased or dying and do not appear to be causing a significant exposure to liability for the City.

The applicant requested that the removal be brought forward for the Commission's consideration as a Category 3 - Discretionary Removals, according to the Streetscape and Median Development Standards (Attachment 3). The applicant has been notified of the Parks and Community Services Commission meeting and has been sent a copy of this staff report.

ALTERNATIVES:

The Commission could authorize the removal and replacement of the trees, per the Streetscape and Median Development Standards, Section 4.0.2 Category 3 - Discretionary Removals, which would require the replacement of the tree at a 3 to 1 ratio. The applicant would pay all removal and replacement costs. The arborist would determine the tree species and locations for plantings.

If the tree removals are approved by the Commission, the payment for the removal and required mitigation trees must be provided to the City prior to the removals and within one year from the date of approval, after which the approval expires.

FISCAL REVIEW:

There would be no fiscal impact to the City if the request to remove the trees were denied, or approved as a Category 3 - Discretionary Removals, as the applicant would pay all costs.

For the Commission's information, removal cost for the trees would be \$1,774.80. The replanting costs for the mitigation trees (3 - 24" box size and 6 - 15 gallon container size) would be \$1,621.80. Costs are based on current City contract prices. The total cost for removal and replacement would be \$3,396.60. The value of the trees is estimated to be \$23,110.00.

LEGAL REVIEW:

No legal review is required for this item.

CONCLUSION:

The three (3) City owned trees that are being requested for removal are located in the public right-of-way on the Gannett Drive side of 1960 Swan Drive. The trees are in good condition and have been maintained on a regular schedule. The trees do not appear to be producing an unusual amount of needle drop for this type of tree. There are no existing concerns regarding liability or infrastructure. Therefore, staff recommends that the Commission deny the request to remove the trees.

Dear City of Costa Mesa,

The giant pine tree planted on the parkway on Gannet Street next to my backyard fence and swimming pool is dropping a great amount of damaging litter and pine needles in my backyard, pool, pool filter and equipment. (See photo)

My pool man told me that the excessive algae in my pool is caused by the filter of skinnwer being clogged by dropping from the tree. He said he will need to clean the filter more than usual because the dropping clog the filter which causes algae build-up and could ultimately damage the filter.

In January 2019, the other giant pine tree planted next to the above tree, blocked and broke the drain at the curb that drains rain water from my backyard. (Which caused a flood in my backyard.) I paid \$525.00 to have it repaired, but it could happen again as the tree grows. (Paradise Design invoice attached.)

I have attached photos of the tree and of the amount of pine needles and litter it drops. Also, the Gannet Street sidewalk has been shaved down due to the tree lifting the sidewalk. I would greatly appreciate the city removing the trees to prevent further damage.







Resident called back. After discussion. The resident only wants the furthest pine tree from Swan Drive removed. This tree is identified as S3. Provided my e-mail address to provide the City's criteria for tree removal and other tree related documents. Stated that I would be out this week to evaluate the health of this tree - JO 3/16/21 - Inspected the tree S3. The tree is a 50' Canary Island Pine tree growing in a turf parkway. There a sidewalk grind behind this tree. Rippling in the street was noticed. A new curb was also noticed. The tree appeared stable, there were no noticeable structural defects or any visible signs of any pest or disease activity present during the time that I inspected this tree. Contacted resident @ 12:26 pm and stated that the tree is deemed healthy - JO 3/03/22 Resident was at City Hall to request tree removals, as she disagreed with the evaluation that the tree is healthy (MStueye), Contacted resident @ 2:37 pm to discuss tree removal requirements. Resident provided her e-mail address and I e-mailed the resident the City's criteria for parkway tree removal - JO 3/27/22 - Received formal request for the removal of the City maintained trees. Reviewed document and provided pictures. Noticed that the letter does not indicate a formal request to remove trees by the PACS Commission. Contacted resident and discussed the tree removal process and the need to formally request to have the tree removal requests be formally heard by the PACS Commission. The resident verbally requested that the tree removal requests be formally heard by the PACS Commission - JO 4/22/22 -Inspected the three (3) trees growing in turi parkways on the Gannett Drive side of this address. The tree identified to be removed is identified as S3. The tree is a 45'-60' Canary Island Pine Tree. The DBH measured at 19". There was one (1) noticeable area where the sidewalk was ground, there is minor curb separations and minor rippling in the street in front of and to the north of this tree. The tree appeared to be stable, there were no noticeable structural defects or any visible signs of any pest or disease activity present during the time that I inspected this tree. The CAT II removal costs will be \$ 581.40 for the tree and stump removal. The 3 to 1 replacement ratio costs is \$ 540.60. The total costs are \$ 1,122.00. This tree was last trimmed on 6/5/18. There were five additional work orders with this address. The two (2) other Canary Island Pine Trees were also inspected and there were no issues found on these two (2) trees. E-mailed City's Engineering Division to see when the last time any street work was performed on both sides of this address- JO 7/1/22 - Resident called back asking for a call back. I verbally explained the PACS commission and that the resident will be receiving a report one (1) week prior to the PACS meeting. Resident wants three (3) trees removed but is willing to have the one (1) tree closest to the pool removed - JO

4.0 CRITERIA FOR PARKWAY TREE REMOVAL/REPLACEMENT

Based on guidelines established by City Council ordinance, the Public Services Director is authorized to approve or deny all tree removal requests, or may agendize any removal request for review by the Parks and Recreation Commission.

Any removal decision made by the Public Services Director may be appealed to the Parks and Recreation Commission for review. Decisions made by the Parks and Recreation Commission are final and may not be appealed to the City Council. The Public Services Director will notify the property owner/applicant of every decision to ensure that any appealed decision will not be implemented until after the appeal is heard.

Decisions made by the Parks and Recreation Commission are valid for a period of one year. All requests for removal and specified mitigation measures approved by the Parks and Recreation Commission must be completed by the applicant within one year from the date of approval. If tree removal and/or mitigation is not completed within one year, the approval is rescinded.

Tree removal denials made by the Parks and Recreation Commission may not be reconsidered for a period of one year from the date of denial.

All property owners/applicants wishing removal of a parkway tree(s) shall complete the "Request for Tree Removal" application available from the Public Services Department. Removal requests will fall into one of three categories:

Category 1 – Health and Safety Removals

Category 2 - Accelerated Removals

Category 3 - Discretionary Removals

4.0.1 <u>Category 1 – Health and Safety Removals</u>

Removal of a street tree at no cost to the property owner/applicant may be considered on the following basis, and in accordance with Public Services policies:

- If the tree is dead, dying, critically diseased, or damaged beyond reasonable repair.
- If the tree is causing a safety hazard (such as significant sidewalk and curb uplifting), and root pruning is determined not to be a viable option. Root pruning, sidewalk shaving, and sidewalk rerouting shall be considered as alternative options when evaluating the removal of trees that are causing safety hazards.

• If the tree presents a foreseeable risk of injury and liability to the public.

If the tree is damaging vital infrastructure (such as sewer, water, gas, electrical conduit) of other major structural damage, proof of damage must be submitted by the property owner/applicant prior to the final approval and scheduling by the Public Services Director.

4.0.2 Category 2 – Accelerated Removals

The City may remove or allow a street tree to be removed, as a "convenience" to property owners or other City departments, if the tree meets the "Accelerated Removal Criteria" and the property owner agrees to the following Criteria and Conditions:

Criteria

- a. The tree(s) is a City designated "Problem Tree Species" (Ficus microcarpa or F. retusa, F. nitida, Fraxinus uhdei, Schinus terebinthifolius, Cupaniopsis anacardioides or other tree species so designated by the Parks and Recreation Commission), or...
- b. The Director may determine to remove a tree based on the following factors and determine the individual tree to be a 'nuisance' and qualify for an Accelerated Removal, with all Conditions to be met in order to allow for the removal of the parkway tree:
 - Any tree, where the amount and/or nature of litter from the tree (pods, seeds, flowers, sap, etc.), is significantly greater than can be expected from a typical tree of that variety; or
 - Any tree, where impacts on surrounding public or private property improvements (i.e. hardscape, landscape, masonry structures, etc.) are significant or are potentially significant in the future; or
 - The tree is causing unreasonable impacts on the property owner where it is located.

Conditions

a. If the sidewalk, curb and/or gutter are damaged by said property owner/applicant (final conditions shall be inspected by the City), the property owner/applicant agrees to pay for all damaged concrete within forty-five (45) calendar days after tree removal. If damage occurs, the property owner/applicant agrees to obtain all permits and provide a bond for completion, and securing a licensed contractor.

- b. If tree is to be removed by City, City staff will prepare a cost estimate for removal based on established contract prices. The property owner/applicant agrees to pay for the service by check or cash. If tree is to be removed by property owner/applicant, the City will require an approved licensed, bonded and insured contractor to remove the tree and stump. Date of removal shall be approved by the Public Services Department.
- c. The property owner/applicant agrees to pay the Public Services Department for tree replacement costs based upon the adopted City Council 3:1 tree replacement ratio. For every one mature tree removed, three (3) new trees consisting of one (1) 24" box tree and two (2) 15-gallon trees shall be planted, with tree locations to be determined by the Public Services Department. Property owner/applicant agrees that the Public Services Department will select the tree species and determine minimum acceptable tree species height, trunk caliper, and crown development criteria.

4.0.3 <u>Category 3 – Discretionary Removals</u>

Requests for removal of City-owned trees in parks, parkways, or rights-of-way not covered under Category 1 or Category 2 shall be agendized for review and determination by the Parks and Recreation Commission.

Final determination by the Parks and Recreation Commission will be based on information provided by the property owner/applicant as well as the following:

- 1) Is the request from City staff, commercial applicant, or residential property owner/tenant?
- 2) Are there alternatives to removal which have not been considered?
- 3) Who will bear the financial responsibility for removal/transplanting/replacement?
- 4) Is transplanting a viable option from the standpoint of tree survivability?
- 5) Is "in-kind" replacement or 3:1 replacement (1-24" box, plus 2-15 gallon) more appropriate?
- 6) What are the aesthetic impacts to the neighborhood or to existing planting themes?
- 7) Does the removal pose any adverse impacts to adjacent property owners?

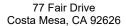

- The Musical Instruments have been installed at the Donald Dungan Library. This project was funded through the Friends of the Costa Mesa Libraries was officially opened with a ribbon cutting ceremony on September 1.
- The Norma Hertzog Center patio project is now complete. The patio is now concrete, with a seating wall and decorative lighting. This space is a great addition to the remodeled Community Center.
- The Brentwood Park playground replacement project is still in preliminary design. Staff are currently planning for community meetings that will be announced later this month.
- The Fairview Park Master Plan Update process will begin in early 2023. Staff are preparing
 to bring a Professional Services Agreement consultant services to City Council later this
 year. The Commission will host community meetings for the Fairview Park Master Plan
 Update.
