

PUBLIC COMMENTS

Samuel Helm: Commended the commissioners for their work and encouraged the arts community to consider donating artwork for fundraising and as incentives for non-profits and community events. Raised the topic of artificial intelligence (AI) in the arts, referencing an email sent to the commissioners with detailed thoughts on the matter. They highlighted the need for transparency and disclosure when AI is used in creating art. Concluded by acknowledging the inevitability of adapting to AI in the creative world.

COMMISSIONER COMMENTS

Commissioner Ashendorf: Spoke about two (2) art events: the "Art That Transforms" event at the Norma Herzog Center, supported by a grant from the commission, which included face painting, art workshops, and a live art auction; and Commissioner Ochoa's "Fruits of Labor" exhibit featuring an interactive vegetable mat. Mentioned that Chair Wondercheck is a nominee for the Orange County Business Journal's Women in Business award, and thanked Vice Chair Zuckerman for their positive impact on local schools through OCMA-supported field trips.

Commissioner Lucia: Enjoyed attending the Arts OC Awards with city members. The event celebrated artists and their supporters across Orange County, and they were pleased to see strong representation from Costa Mesa.

Vice Chair Zuckerman: Celebrated October as National Arts and Humanities Month and hosted the City's Art Venture award ceremony at the museum. Announced that OCMA received \$15,000 from the Arts and Culture Master Plan initiative for offering free arts workshops to Costa Mesa residents and the workshops will run throughout the year. Reported that hotel tax revenues in Costa Mesa are projected to exceed pre-pandemic levels, reflecting a shift toward spending on experiences over goods. Given this economic boost, she suggested Costa Mesa consider implementing a hotel tax or a percent-for-art program to further support arts-driven tourism and revenue.



UPDATES:

Art Crawl

The Art Crawl Experience on October 12th was well received by participants. We had 22 people shuttle to three locations: South Coast Plaza, Sean Woolsey Studio and ARTime Barro. Participants learned about the history of the Jewel Dome in South Coast Plaza and also about how the building came to be known as a luxury retail destination. Sean Woolsey hosted the group and talked about how he started his business and provided details about the items his team create: pool tables, shuffleboard tables, ping pong tables and chairs. He also gave a tour of his studio space. At ARTime Barro, participants learned how to make a bowl using the hand building technique and Nicole, the owner, also explained the glazing process and how often clay needs to be fired to harden correctly. Bowls are currently being glazed and almost ready for pickup.

❖ Poet Laureate Program

The application has now closed for the Poet Laureate program application. We have four (4) new applicants. I will be contacting the previous review panel to assemble again, review the new applications and conduct interviews in the next few weeks. The goal is to have a new Poet Laureate selected to present to the Arts Commission in January/February of 2025. Once approved, staff will work with the selected Poet Laureate to create a scope of work for the following year.

Utility Box Art Program

The utility box art program application is now open and available online. We currently have eight (8) applications. The application will close on December 31, 2024. This year, staff will be forming a review panel that will include one (1) to two (2) Arts Commissioners to review all the applications and select fourteen (14) new designs to present to the Arts Commission for final approval. This year, we will be removing nine (9) older vinyl wraps and replacing them will new designs. New designs will be places from February to July of 2025.

BACKGROUND:

The Art in Public Places Report created by consultant Arts Orange County, was approved by the Arts Commission on April 6, 2023 to address aspects of the Arts and Culture Master Plan's Goal #2: Expand Public Art throughout the City.

Action 2.2: Develop a plan for more ambitious temporary and permanent public art, including the identification of potential locations around the City, creation of policies with respect to selection and acquisition of artworks, and determination of the funding sources to be used.

On May 4, 2023, the *Public Art Criteria and Guidelines* were established to guide future public art projects, both temporary and permanent. These guidelines were presented to and approved by the Arts Commission.

On June 6, 2024, The Mural Permit Application is available online in the City of Costa Mesa's permitting software, TESSA, and presented to Arts Commission.

ANALYSIS:

The owners and operators of Anduril, a private business at 1400 Harbor Boulevard, Building A in Costa Mesa, will commission program designer, JB3D to create a mural banner on the side of the building facing Harbor Boulevard.

The mural permit application has been submitted through the TESSA system, with images and dimensions of the proposed design attached to the original application (Attachment 1).







RECOMMENDATION:

BACKGROUND:

On March 21, 2021, the Arts and Culture Master Plan approved by the City Council. This Master Plan included specific goals for City's art initiative.

The Arts and Culture Master Plan states the following:

Goal number 2: Expand public art throughout the city.

Objective 2.1: Establish and grow a world class public art program that serves all districts and neighborhoods.

Action 2.3: Create a new program of temporary installations of large-scale sculptures as two-year loans, placed at sites inclusive of all the City's districts. This can be ramped up gradually by installing three works in Year 1 (one in each of three districts), adding three in Year 2 (in the remaining districts), and then continuing to rotate the works on expiring loans annually.

ANALYSIS:

In early 2024, staff began developing a plan to address Action Item 2.3. After careful evaluation, they moved forward with hiring a landscape designer to create a concept for a sculpture garden it potential park locations.

As this initiative requires official design and construction, the sculpture garden project must be submitted to the City Council for consideration as part of the proposed Capital Improvement Program (CIP) budget, in line with the City's Arts and Culture Master Plan.

Annual funds have been allocated to the Arts & Culture fund for the installation of public art starting in fiscal year 2023-2024. Currently, unused funds from previous years are rolled over for this public art initiative.

Staff engaged Sitescapes, a landscape planning and architecture firm, to prepare a conceptual rendering. This will enable the commission to provide feedback and recommendations on site options and concepts, positioning the project for inclusion in the 2025-2026 CIP budget.

FISCAL REVIEW:

The Public Art Sculpture Garden project is currently partially supported with funds from the Arts & Culture Fund, as outlined in the Arts & Culture Master Plan.

LEGAL REVIEW:

There is no legal review required for this report.
