**PUBLIC COMMENTS**

Flo Martin: Costa Mesa resident and dedicated supporter of the performing and visual arts, has been a subscriber to numerous cultural organizations. She recalls a particularly moving experience at the Pacific Symphony's Symphonic Soul: A Celebration of African American Artistry, which brought her to tears and evoked memories of her student days at UC Berkeley.

Samuel Helms: A poet and hobbyist in AI-generated music, has transformed 325 of his poems into songs and encourages the commission to explore the potential of AI in supporting local poets and musicians. He also proposed a structured cultural presentation before city council meetings, featuring an "Artist of the Month," a poet, a musician, and a craftsman or specialist artist. Helms suggested that local college students in communication fields could moderate and produce these segments, providing them with valuable public access TV experience while enriching the cultural engagement of the community.

**COMMISSIONER COMMENTS**

**Commissioner Ochoa:** Expressed gratitude for returning to the commission and shared highlights from recent art events in the community. She also echoed praise for Commissioner Wondercheck's *Symphonic Soul*, noting its emotional impact and sold-out success.

**Commissioner Ashendorf:** Took a moment to acknowledge former Vice Chair Arts Commissioner, Heidi Zuckerman, for her contributions, and encouragement within the community and encouraged the community to read her book and blog, *The Importance of Art*. She also highlighted the Costa Mesa High School event featuring *Backhaus Dance*, a grant-funded program that greatly benefited students. Additionally, she announced a free

artist talk by muralist Alicia Rojas at the Norma Herzog Center on March 9 and requested staff updates on new public art bike racks in the city.

**Commissioner Lucia:** Commended City staff and the Arts Commissioners for their work on the utility box art program, noting the increased number of submissions from both local and countywide artists. She expressed appreciation for the growing community engagement in the program over the past two years.

**Commissioner Derderian:** Thanked Councilmember Pettis for his reappointment and shared his enthusiasm for continuing his work with the commission. He also voiced support for Samuel Helms' suggestion of incorporating artistic performances or exhibits at the start of commission meetings, stating that he would like to see the idea implemented in some form.

## **2. REVIEW AND APPROVE NEW POET LAUREATE AND SCOPE OF WORK**

Laurette Garner, Arts Specialist, presented.

Poet Laureat, Danielle Hanson, introduced herself to the Commission.

Commissioner Ashendorf welcomed the Poet Laureate and acknowledged the long-awaited nature of the appointment. She also inquired about the timeframe for receiving official updates from the Poet Laureate, suggesting a six-month report to keep the community informed about progress and future plans.

Commissioner Ochoa expressed enthusiasm for the Poet Laureate and raised a question about the non-exclusive license outlined in the agreement. She suggested setting a clear time limitation to protect both the city and the artist and proposed an attribution clause to ensure proper credit whenever the writer's work is displayed.

## **3. APPROVAL OF UTILITY BOX ART PROGRAM APPLICATIONS**

Laurette Garner, Arts Specialist, presented.

Commissioner Derderian highlighted several submissions that stood out, specifically praising works by Harlow Brezeale and Karen Gallo. However, he pointed out the art formatting of Lisa Corinne Kelson's box, which appeared distorted, and asked whether this would affect the final display. He also raised concerns about Craig Barker's submission, finding its depiction of the female form potentially inappropriate for public display, as it could be perceived as objectifying.

Commissioner Ashendorf recalled that Craig Barker had previously designed a utility box that sparked controversy, questioning whether the same concerns applied to his current submission.

Commissioner Ochoa echoed some of Derderian's concerns, noting that while the artwork's title, *Mesa Girls Are the Cutest in the Land*, had a playful tone, it did not fully capture the depth and strength of the women in the community. She suggested a title that better reflected their resilience and multidimensional nature.

Commissioner Mann shared an appreciation for Craig Barker's work, acknowledging that his artistic style might take time to grow on viewers. She felt that the artwork captured the spirit of local "punk, cool, and beachy" Mesa girls and did not find it objectifying. She particularly admired the inclusion of Doc Martens in the design, seeing them as a nostalgic representation of a specific era and cultural identity.

Commissioner discussion ensued regarding the selection process and alternate box options.

### **BACKGROUND:**

The City of Costa Mesa owns over 120 utility boxes at signalized intersections throughout the city and is dedicated to incorporating art into public spaces. A Utility Box Art Program was launched in early 2015 to spotlight a handful of utility boxes as beautiful art pieces. The city currently has over 60 utility art boxes that display artwork created by local artists; and 10 boxes designed by graphic designers from local businesses and nonprofit organizations.

For fiscal year 2024-25, a review panel was formed to review all designs and make selections to present to the Arts Commission. The review panel consisted of two (2) Arts Commissioners and one (1) local artist.

On February 6, 2025, the Arts Commission approved eleven of the twelve designs presented. The twelfth design selected, by artist Craig Barker, was tentatively approved pending a redesign to address concerns from the Arts Commission. Staff requested Mr. Barker, submit a redesign for the twelfth box, however, the artist declined and a re-submittal was not provided.

### **ANALYSIS:**

Staff is requesting review and approve an additional design for the 12th and final box. The following are the alternates as approved by the review panel.

Location assignment is tentative, pending Arts Commission review and approval.

**LEGAL REVIEW:**

No legal review is required for this item.

**FISCAL REVIEW:**

The Arts Division receives an annual budget for the Arts & Culture Master Plan implementation, which includes the utility art box program. The 2024-2025 budget allows for the installation of 12 new box designs.

### **2. Artist: Kimberly Duran**

#### **Short Bio:**

Kimberly Duran is known professionally as "Shmi". Her journey into the realm of art began in Santa Ana, where she was born and raised. From a young age, she found solace and purpose in the act of creation, initially expressing herself through the crafting of mural backdrops for local plays at the age of 11. Her identity as a first-generation Chicana plays a pivotal role in shaping the essence of her artistic expression. Raised by migrant parents who settled in Santa Ana, she has always felt a profound connection to her cultural roots. Growing up, frequent visits to Mexico exposed her to a rich tapestry of traditions, customs, and values, instilling within her a deep sense of pride in her heritage. Her art serves as a reflection of this journey, weaving together themes of identity and belonging. Through the lens of her experiences and observations, she strives to amplify the voices and narratives of those who inhabit the spaces around her. With aerosol and acrylic as her chosen mediums, she specializes in the creation of large-scale mural paintings that speak to the soul of her community. Rooted in the traditions of folk art, her work is a celebration of the vibrant cultural life that thrives within Santa Ana. ### **BACKGROUND:**

The Cultural Arts Committee (CAC) implemented an Arts Grant program in 2017, funded by money generated through ARTventure fees and Utility Box Art Program sponsorships. As of May 25, 2021, the CAC Grant Program had distributed \$11,375 to twenty-three arts related projects organized by artists and arts organizations hosted within the City of Costa Mesa.

One of the requirements for accepting arts grant funds from the City of Costa Mesa is to also complete a final report to present the benefits of approved projects and or events. Each awarded organization or artist must complete an online Final Report and has twelve (12) months to spend their funds from the time the funds are dispersed. Funds are typically dispersed in May of each fiscal year.

**ANALYSIS:**

Final reports will be presented to the Arts Commission annually. For the fiscal year 2024-2025, the arts grant application is open until March 10, 2025. Applicants will be reviewed by an outside review panel that consists of arts administrators, educators and Arts Commissioners and funds will be distributed in May of 2025 for a final report out in May of 2026.

**FISCAL REVIEW**

Funding for the Arts Grant Program is currently supported with funds from the Arts & Culture Plan Fund as per the Arts & Culture Master Plan. The fund had \$5,000 to distribute for the 2022-2023 fiscal year and \$7,500 to distribute for the 2023-2024 fiscal year.

The 6th annual Mesa Jazz Festival 2023 was a huge success. The Costa Mesa High School Instrumental program welcomed 8 local high school Jazz Bands to perform for adjudicators, be evaluated, and receive both group direct feedback/instruction, as well as section master classes. The performance portion of the event was open to the public, and we hosted over 200 guests over the course of the event. Many parents who came to see their student's performance, stayed to enjoy the performances of other schools as well.

The Costa Mesa High School band boosters hosted the event, and we provided 2 dozen volunteers over the course of the day to make everything run smooth.

We evaluated our success by how smooth (i.e. on schedule) everything ran, by the number of guests we welcomed to the theater, and by the number of students attending and receiving master-class level feedback on their jazz studies from industry working professionals. We did not hold this event in 2020 or 2021, and only partially in 2022 (the schools did not interact as much due to covid restrictions). So this was the first full-year back and so enjoyed and appreciated by all.

## 2023 Wild & Scenic Environmental Film Festival



cloudy Saturday September 30, with a chance of and fighter jets fly overs, a unique environment for our Wild & Scenic Environmental Film Festival here in a usually quiet corner of Costa Mesa. Despite these unexpected challenges our volunteers persevered, and our audience enjoyed two screenings of five short documentary films and interviews with filmmakers, informational environmental displays in the courtyard and a beautiful photography exhibit from a professional Ukrainian photographer, Iryna Obukhovska. This year's film selection highlighted environmental issues such as the importance of falconers and how they helped a species recover from threats of DDT, reindeer herders in Mongolia, the connection of microbes with the health of bees, and how personal challenges unexpectedly motivate environmental awareness and action. An example is our feature film, "The Scale of Hope", followed Molly Kawahata, a climate advisor to the Obama White House, working hard on policies of climate change, while privately managing a bi-polar diagnosis and pursuing her passion for ice climbing. Each of the films showcased how a relationship with the natural world can spark a passion to preserve these special wonders, like an octopus, falcons, reindeer or bees, or the incredible beauty of remote Alaska. These special connections with nature can motivate action and awareness so that these beautiful experiences continue for others to enjoy. These inspiring documentary films are a unique art form that not only are a feast for the eyes and mind but use their art to connect with the viewer and motivate them to care about our world.



We were fortunate to have two of the film makers, Josh "Bones" Murphy ("The Scale of Hope") and Carmen Morrow ("The Dukha") participate in an interview with journalist Andrea Plate (see photo on the left) which allowed our audience to learn more about the challenges and motivation of these artists, and how their creative efforts can make a positive impact on the world. Josh Murphy answered questions about capturing the dramatic film footage of the climbers in steep icy mountains in remote Alaska, and Carmen shared her experience of traveling to northern Mongolia to film the nomadic herders that live with their wild reindeer.

Before the war broke out in Ukraine in 2022 professional photographer Iryna Obukhovska had visited and documented her travels in over 50 countries, from Afghanistan to Myanmar and Tanzania, where she conquered Kilimanjaro. Her photos have been published in print and online in media outlets including Marie Claire and National Geographic. (Iryna Obukhovska, on the right, with one of the photographs displayed during the film festival.)

The generous grant from the Costa Mesa Arts Commission was instrumental in covering the fees for the films, from the Wild & Scenic Film Festival, headquartered in Yuba City, CA, and travel costs for the guest filmmakers.



Comments we received from our over 100 attendees:

- Congratulations on a beautiful festival.*
- I truly enjoyed the lineup of films. Delightful and educational for me.*
- I really enjoyed the film festival and thought Linda and her team are fabulous!*



*-I thought the food was a “step-up” from last year. The presentation was better too. I think \$25 per ticket is a fair price, and Vanco platform seems to be the way to go since our people are familiar with it.*

*-I am happy to volunteer more next year.*

*-The Q&A section with Film makers is a nice feature. I agree with the comment that it reinforces the “festival” concept. I think having some audience participation in the questions being posed is a great idea. It would be nice to feature art every festival, with different artists each time, with an environmental tie in with their art.*

*-I loved this year’s selection; it was a great combination of kid-nature lover, local minority falconer, exotic close-to-nature community, science education, and inspiration/hope regarding climate change. I recommend going for a similar balance next year. It would be cool to find a film about making science more accessible and equitable.*

*-I couldn’t attend Iryna’s exhibit, but thought it was a nice tie-in to the festival. I really liked the choice of interviewer (the journalist). She did a great job during the Q&A. The Q&A really makes it “feel” like a film festival, and it is important that we select films that have local filmmakers who can participate. I really like this year’s selection of films. I liked that we had a longer film anchoring the festival.*

*-I thought the photography exhibition was great and people felt good about supporting Iryna as a Ukrainian refugee. I also like having 1-2 filmmakers to discuss their films; this is a very special component we offer.”*

We received some suggestions to improve our film festivals, possibly having just one screening next time instead of two. Also, we hope to be able to avoid possible conflicts that might affect attendance counts. This year the Huntington Beach Air Show announced their dates after we had coordinated with the Wild & Scenic Film Festival flagship organization for a showing. We were careful to avoid competing with the Newport Beach Film Festival, but this year they are featuring more films in an



environmental category so we don't know if that affected our ticket sales, but possibly. Also, unfortunately, COVID may have been a factor since the number of cases were rising again, and the next booster had just been announced. We had hoped to sell more tickets but as we all know Costa Mesa, and the surrounding community, has a variety of great artistic and environmental activities to choose from every weekend, which is one of the best reasons we all are fortunate to live in this area.

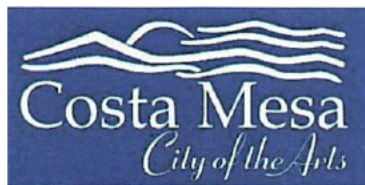

We held three public engagement meetups in the City of Costa Mesa to meet and greet and ask LGBTQ+ and BIPOC skateboarders. We offered the opportunity to learn how to skateboard from them and meet skateboard athletes from other nearby cities that traveled to Costa Mesa to discuss their interest in the sport and what it had to offer them. I had a rough time procuring an exhibition space for the art work and photograph from the project. I went to the book I was given about Costa Mesa's Art Master Plan and looked to see who structured it. From there I did outreach to a Mr. Payan and Mr. Stein. I was able to organize an art show about the art project and do a dual art cooperative project with Mr. Payan's new art Gallery in Santa Ana called Masarte Gallery. This project helped strengthen the art community and ties between the cities of Costa Mesa and Santa Ana, Ca. Through the course of a year I was able to do 3 different community art gallery exhibitions with the project including the Irvine Fine Arts Center, OCCA and Laguna Beach Pride. Additionally the skateboard project made it into two different media publications. Further I was invited twice to the radio station KXFM to talk about the project. Through my project I placed a lot of emphasis on Lesbian Latina and trans skateboarders. My project was able to elevate their visibility and provide a platform to discuss the fight for greater visibility within the sports world of skateboarding as well as other sports. The project attracted the attention of several members of the California Arts Council and several museum curators around California. I look at this as a bonus because it affords me the opportunity to help others capture some of the misdirected attention that some of the athletes and organizers of events deserve or have been overlooked by others for far too long. I was invited to participate in several zoom meetings about the project. This in turn made a lot of other individuals approach me or ask to participate. I had to do a lot of traveling with the project in order to bring new people to the City of Costa Mesa to meet other LGBTQ+ / BIPOC or trans skateboarders. I began reaching out to business owners in the city to discuss the project like Win Lam of Wahoos and Bliss Magazine/Art Gallery.

It has come to the point where the artists no longer need the support of the Cities and States but rather the State needs the support of the artists in order to keep it relevant and capture global attention for commerce with other states and countries. As I progressed on my project I was beginning to attract global attention. Already I have a sticker exchange in the works with an LGBTQ+ skate club and one in Iraq. This is important because Iraq's government has just imposed the death sentence if you are found out to be LGBTQ+. Suddenly what seems insignificant with a City funded art project can have dramatic impacts and change others lives in positive ways. What we do here can give others hope that have less fortunate circumstances. An art liaison will have the ability top check in with the artists. See an observe and have a greater capacity to explain to city officials potential or missed opportunities and how to capitalize on them. During this past year I felt I was on my own for the most part with my art project. I had to do a lot improvisation with it. I had to build an enormous amount of bridges. It was really tough going at times. An art liaison could have seen relevancy in my project and spotlighted it out to Costa Mesa Foundations or business owners to partner up. I handled all my own publicity on this project this year from the radio interviews to the magazine stories. It would have really been great if someone else had leant just a little help. Does Costa Mesa have a dedicated page spotlighting all the artists and designers in the city? I didn't find it but that's important. The City of Costa Mesa has a dynamic art base from hot rod car designers, surf and apparel designers, visual artists dancers, writers and photographers to name a few. However, without the aid of the city they often remain unknown to the cities residents and others in the state of California. I hope you all address this and make some dynamic changes.

Dear Costa Mesa Arts Council,

I am writing to express my gratitude for the artist grant of \$500 that I received from you last year. I would like to thank you for your support in funding two skateboard events at my art space in Costa Mesa. These events provided a platform for BIPOC and LGBTQ+ skateboarders to come together and share their stories.

In addition to the events at my art space, I also organized a skateboard meetup at Volcum Skatepark in May of 2024. This meetup allowed the public to meet and interact with skateboard athletes from diverse ethnic backgrounds, all in relation to the "Out In the Streets" project. Throughout the year, I showcased paintings and photographs from this project at various community art galleries across Los Angeles and Orange County, including the Irvine Fine Arts Center, OCCCA, and Tom of Finland Foundation.

Thanks to the Costa Mesa "Out in the Streets" project, I had the opportunity to participate in two radio interviews with KXFM. The first interview took place at the beginning of the project, while the second one marked the end of the first year. Although I displayed images from the project multiple times at my art space, I wanted to increase its visibility. Unfortunately, I couldn't find a suitable location within the city. To overcome this challenge, I consulted the Costa Mesa master plan book and discovered that Richard Stein and Victor Payan were involved in organizing it. Having previously met Victor on several occasions, I approached him and asked if we could showcase a significant portion of the project's work at his art gallery in Santa Ana, called Masarte.

The final outcome of the project was a collaboration between the two art events, organized jointly by Costa Mesa and Santa Ana arts activist, with Victor and me at the helm. This collaboration included the skateboard meetup at Costa Mesa Volcum Park on Friday and the art opening the following day featuring photographs from the "Out In the Streets" project at Masarte Art Gallery in Santa Ana. Many artists and individuals expressed their appreciation for the unique collaboration between two art cities on a community art project. We also received congratulations from the OC Arts Council for our efforts.

Furthermore, I managed to acquire two magazine stories regarding the project. One was featured in a newly established magazine called Obliviana, while the second was published in the renowned zine magazine known as Homosurealism. This particular magazine highlighted the project twice throughout the year, resulting in congratulations pouring in from individuals all over the world. It was an exhilarating moment to receive feedback from people in England and France, acknowledging our efforts.

However, a challenging aspect of the project was attempting to capture the attention and collaboration of Costa Mesa sports apparel companies such as Vans, Volcum, and RVCA. Feeling frustrated, I sought assistance from the LGBTQ+ OC Center. Currently, they are aiding me in establishing a connection with the Vans Corporation for the second year of the project, "Out In the Streets."

As a personal recommendation to the Costa Mesa Arts Council, it would be advantageous to appoint a liaison between artists and Costa Mesa businesses. This liaison could identify potential collaborations and opportunities for artists and businesses on special projects. When I approached these Costa Mesa institutions, I encountered a lack of warmth, even after submitting a cover letter and supplementary materials about the project. It would be beneficial to have an arts representative from the City of Costa Mesa who could facilitate communication between businesses and artists, fostering creative opportunities for future endeavors.

Currently, with the project I have been submitting proposals for a LGBTQ+ / BIPOC 2028 Olympic murals. Additionally, I have written a letter to the Olympic Committee of the United States to initiate collaboration between the "Out in the Streets" project and the 2028 Los Angeles Summer Olympics. I have begun filming the athletes and started creating mini short featurettes about many of them. I am grateful to the City of Costa Mesa and the Costa Mesa Arts Council for providing me with the opportunity to launch the project and showcase some of the incredible and giving athletes through various narrative forms with the "Out In the Streets" LGBTQ+ / BIPOC Skateboard project.

The "Movement Mosaic: Explorations and Innovations in Contemporary Dance" performance on Thursday, January 30, 2025, at the Gilboe/Lindfors Theater at Costa Mesa High School was a resounding success, profoundly impacting 300 students from various Costa Mesa schools. This event, made possible by the City of Costa Mesa Arts Grant 23-24 program, achieved its objectives in several ways:

1. Providing an Engaging Educational Experience:

The performance offered middle and high school dance and theater students an immersive introduction to Backhausdance, Orange County's professional contemporary dance company and this art form many had not previously encountered. By breaking down elements such as choreography, music selection, lighting and costuming, the event provided a comprehensive understanding of the creative process. This approach aligns with findings that exposure to live performances enhances students' engagement and appreciation for the arts. The piece of repertory performed was "Hive," choreographed by Jennifer Backhaus, founder and artistic director, with themes of bees, environment, community and relationships. The title was adjusted to "Deconstructed: Hive" in promoting the program to educators so they could understand which work would be performed.

2. Reflection and Question and Answer Session:

The program included a chance to meet the dancers and engage in a reflection/discussion after the performance. The interactive format encouraged students to ask insightful questions, resulting in an informal dialogue between the performers and the audience. This engagement deepened everyone's appreciation and understanding of the dancers and the piece, sparked new curiosities, creativity and critical thinking.

3. Exposure to Career Pathways: Collaborating with Newport-Mesa USD teachers and VAPA Coordinator Tamara Fairbanks, the event highlighted various career opportunities within the performing arts. By highlighting the different parts involved in a dance production, students gained valuable insights into potential professional pathways, inspiring future aspirations in the arts. This exposure is crucial in broadening students' perspectives on viable careers in creative industries.

4. Alignment with Educational Goals: The program supported the City of Costa Mesa's Arts & Culture Master Plan by promoting equitable access to arts education. By reaching a diverse student population, the event addressed the need for inclusive cultural enrichment, contributing to the development of a vibrant, creative community. Access to quality arts education has been linked to improved academic performance and social-emotional development.

5. Positive Feedback and Lasting Impact: Feedback from both students and educators was overwhelmingly positive, with many expressing a newfound appreciation for contemporary dance. The enthusiasm and curiosity sparked by the performance indicated a meaningful impact, encouraging continued engagement with contemporary dance and the arts. Such experiences are instrumental in fostering a lifelong connection to cultural activities. The teachers that attended expressed interest in continuing to provide contemporary dance workshops with Backhausdance to their students so they can be immersed in working with professional dancers.

In summary, the "Movement Mosaic"/ "Deconstructed: Hive" performance successfully enriched students' educational experiences, promoted cultural awareness, and aligned with community arts education objectives, demonstrating the profound benefits of integrating professional dancers/artists with educational curricula. Thank you to the City of Costa Mesa Arts Commission for this grant! It made a difference!

# ABOUT THE PROGRAM

Austrian composer Franz Joseph Haydn's *Missa in Tempore Belli* (Mass in the Time of War) from 1796, also known as the *Paukenmesse* (Timpani Mass), is one of his six great late Masses, and one of fourteen complete Mass settings. Composed in the same decade as his choral-orchestral masterpiece, the oratorio *The Creation*, and his twelve London symphonies, it is a standard work today in the concert Mass repertory and represents a summation of Haydn's compositional techniques. Many believe this and his other late masses inspired Beethoven's large-scale *Missa Solemnis* (1819-1823).

The *Missa in Tempore Belli* was composed when Austria was preparing for possible war with France under Napoleon, thus the title of the work. (The alternate title refers to the prominent use of the timpani.) The decade of the 1790s was a time of great creativity for Haydn, freed as he was from the regular duties of Kapellmeister (Music Director) for the Austrian house of Esterházy that he had exercised under the great music lover Prince Nicholas I, his earlier patron. Prince Nicholas II (the grandson of Nicholas I) valued Haydn's long service to his family and appreciated his music, but mostly required him to compose annual Mass settings celebrating the name day of his wife, Princess Maria Josepha Esterházy. Thus Haydn benefited from the financial

support and freedom to compose as he wished, which resulted in his late choral-orchestral, symphonic, and chamber music masterpieces.

Haydn's Mass is an expansive, large-scale work, symphonic in conception and scope. It sets each of the five movements of the Mass Ordinary—the Kyrie, Gloria, Credo, Sanctus, and Agnus Dei, the texts sung or recited every day in the Catholic church year. (He gives the Benedictus, the latter half of the Sanctus, its own movement.) The music of each section of each of the movements is set differently to reflect the meaning of the texts. The work is written for four-part SATB chorus, four vocal soloists, and orchestra. Although all four soloists participate throughout the work, Haydn gives the majority of the solos to the soprano and bass, emphasizing the polarity of the high and low voices. The *Missa in Tempore Belli* is a fine example of his mature compositional style of the 1790s, with its effective balance of formal structures, harmony, and instrumentation; the carefully set musical dialogue between the chorus, vocal soloists, and orchestra; and the abundance of musical ideas that serve well the meaning of the Latin text.

The opening movement is unusual because instead of setting the usual tripartite Kyrie text, with its equal repetitions of "Kyrie eleison, Christe eleison, Kyrie eleison" (Lord have

mercy, Christ have mercy, Lord have mercy), Haydn reduces the "Christe eleison" section considerably, emphasizing instead the Kyrie eleison section of this Mass movement. The Gloria movement includes a beautiful, lyrical instrumental obbligato in the middle, slow section of the movement, accompanying the words of supplication "Qui tollis peccata mundi, miserere nobis..." (You who take away the sins of the world, have mercy on us...).

Haydn's Credo, the middle movement of the Mass Ordinary and the central statement of Christian belief, opens with a formal fugue, which he carries on in contrapuntal fashion, showing his mastery of counterpoint, an essential building block of compositional technique since at least the Renaissance. The Benedictus section of the Sanctus, unusually set separately here, is mostly written for solo vocal quartet, with reduced choral interjections. The sound of distant thunder produced by the cannons of war is suggested by Haydn's title, and is heard here through the use of military fanfare-type writing and percussion. The timpani solo in the Agnus Dei, the last movement, heightens the intensity of the prayer for peace and mercy on the text "Agnus Dei, qui tollis peccata mundi, dona nobis pacem" (Lamb of God, who takes away the sins of the world, grant us peace).

**ROBERT ISTAD**, a Grammy Award-winning conductor who “fashions fluent and sumptuous readings” (*Voice of OC*) with his “phenomenal” artistry (*Los Angeles Times*), was appointed Pacific Chorale’s Artistic Director in 2017. Under his leadership, the chorus continues to expand its reputation for excellence for delivering fresh, thought-provoking interpretations of beloved masterworks, rarely performed gems and newly commissioned pieces. In July 2023, he led Pacific Chorale’s first international tour in seven years, conducting performances at leading venues in Austria, Germany and the United Kingdom. His artistic impact can be heard on two recent recordings featuring Pacific Chorale, including the 2022 Grammy Award-winning “Mahler’s Eighth Symphony” with the Los Angeles Philharmonic Orchestra conducted by Gustavo Dudamel on Deutsche Grammophon (2021), for which he prepared the chorus. It won Best Choral Performance and also garnered a Grammy nomination for Best Engineered Album, Classical. Additionally, Istad conducted the Pacific Chorale’s recording “All Things Common: The Music of Tarik O’Regan” released on Yarlung Records (2020). He regularly conducts and collaborates with Pacific Symphony, Berkshire Choral International, and Yarlung Records. His extensive credits also include recording for Sony Classical and guest conducting Long Beach Symphony Orchestra, Bach Collegium San Diego, Musica Angelica Baroque Orchestra, Bath Philharmonia, Bournemouth Symphony Orchestra, Tesseract Baroque, and Freies Landesorchester

Bayern. Istad has prepared choruses for such renowned conductors as Esa-Pekka Salonen, John Williams, John Mauceri, Keith Lockhart, Nicholas McGegan, Vasily Sinaisky, Sir Andrew Davis, Bramwell Tovey, Carl St.Clair, Eugene Kohn, Giancarlo Guerrero, Marin Alsop, George Fenton, and Robert Moody. An esteemed educator, Istad is Professor of Music and Director of Choral Studies at California State University, Fullerton, where he was recognized as CSUF’s 2016 Outstanding Professor of the Year. He conducts the University Singers and manages a large graduate conducting program, in addition to teaching courses on conducting and performance practice. Istad, who is on the Executive Board of Directors of Chorus America and serves as Dean of Chorus America’s Conducting Academy, is in demand as guest conductor, lecturer, and clinician.



South Korea-born **DR. JUNG-A LEE** has performed in Europe, North America, Asia and Africa as an organist, pianist, harpsichordist, and conductor. She currently serves as organist at St. Andrew’s Presbyterian Church in Newport Beach, California, and sub-dean of The American Guild of Organists Orange County Chapter. Lee is also on the faculty of Biola University, Concordia University in Irvine, Vanguard University, and Orange County School of the Arts. In 2009 Lee founded Music Mission International to promote classical music focusing on organ. In addition, she works for Pacific Chorale and Pacific Symphony as keyboardist.

Lee has performed at many venues in France, Germany, Italy, England,

Wales, Slovakia, Hungary, Canada, China, Hong Kong, Nigeria, and South Korea. In the United States she has given solo organ recitals in venues including the Cadet Chapel at the United States Military Academy in West Point, New York, St. Thomas’ Episcopal Church in New York, Woolsey Hall at Yale University, The Memorial Church and Rudolph Busch Hall at Harvard University, Washington National Cathedral in District of Columbia, Methuen Music Hall in Massachusetts, Grace Cathedral in San Francisco, Renée and Henry Segerstrom Concert Hall in Costa Mesa, Crystal Cathedral (Christ Cathedral currently) in Garden Grove, the Cathedral of Our Lady of the Angels in Los Angeles, and First Congregational Church in Los Angeles. From 2018 to 2023 she played with David Chang (clarinet) and Cynthia Ellis (flute) as Synergy Trio. They were featured for the MTAC Convention in 2021 and 2022 as well as the National Flute Association Convention in 2023.

She completed the Doctor of Musical Arts in organ performance from Boston University. Her dissertation was on Petr Eben (1929-2007)’s Chamber Music. In Boston, Lee served as an organ scholar of The Memorial Church, Harvard University from 2001 to 2003, whose services were broadcast on the radio. She earned her Master of Music in organ performance from Yale University with a full scholarship and worked as a collaborative pianist for the Opera School at Yale. While studying there she received numerous prizes including the Charles Ives Prize. From 1996 to 1997 she studied at Humboldt University and Kirchenmusikschule in Berlin, Germany as an exchange student. While studying in Toronto, she served as an organist at Timothy Eaton Memorial Church whose services were broadcast on the radio. In addition, she holds a London Trinity College Licentiate Diploma in piano performance.

Her organ and improvisation teachers include Thomas Murray, Martin Jean, Gerre Hancock, John Tuttle, Karl Hochreither, Michael Bloss, and William Wright. Also, her harpsichord teachers are Menno

van Delft and Lori Loftus. Lee also participated in the master classes with Olivier Latry, Marilyn Keiser and Susan Landale. She worked with fine conductors including Christopher Hogwood, Doreen Rao, Carl St. Clair, John Alexander, Robert Istad, Bramwell Tovey, Murray Somerville, Joseph Huszti, Chai-Hoon Park and Locky Chung.

Lee can be heard as organist on *Rorem: Works for Choir and Organ/Harvard University Choir* CD on Black Box label (catalog number 1102), on the recordings of the Men in Blaque of University of California, Irvine, and the recordings of the Concert Choir of Vanguard University of Southern California. Her first DVD of Music Mission International, "Beauty in the Wind," was released in 2010. Several pieces from the DVD were broadcast on the radio program, "Pipedreams" hosted by Michael Barone ([pipedreams.publicradio.org](http://pipedreams.publicradio.org)). In 2012 her CD, *Precious Lord* was released, which includes numerous hymn arrangements and features David Washburn (trumpet), Valerie Geller (violin), and Lori Loftus (piano). In 2013 she was also featured at KUSC, 91.5 FM MHz, South Carolina ETV and Kookdong Korean Christian Radio. In 2014 her 90-minute organ solo recital was broadcast on KVPR, 89.3 FM. Her CD, *Amazing Grace* was recorded at Walt Disney Concert Hall in Los Angeles on the organ built by Rosales/Glatzer-Götz. **RHETT M. # PACIFIC CHORALE



The GRAMMY® Award-winning PACIFIC CHORALE, an Orange County “treasure” with a “fresh viewpoint” that “can sing anything you put in front of it with polish, poise and tonal splendor” (*Orange County Register*), has “risen to national prominence” (*Los Angeles Times*) since its inception in 1968. Hailed for delivering “thrilling entertainment” (*Voice of OC*), the resident choir at Segerstrom Center for the Arts is noted for its artistic innovation and commitment to expanding the choral repertoire. It has given world, U.S., and West Coast premieres of more than 40 works, including numerous commissions, by such lauded composers as John Adams, Jake Heggie, James Hopkins, David Lang, Morten Lauridsen, Tarik O'Regan, Karen Thomas, Frank Ticheli, András Gábor Virág, and Eric Whitacre. In addition to presenting its own concert series each season, Pacific Chorale, led by Artistic Director Robert Istad, enjoys a long-standing partnership with Pacific Symphony, with which the choir made its highly anticipated Carnegie Hall debut in 2018. The chorus also regularly appears

with the Los Angeles Philharmonic, with which it won the 2022 Grammy Award for Best Choral Performance for its contribution to the live recording of “Mahler: Symphony No. 8, ‘Symphony of A Thousand,’” conducted by Gustavo Dudamel, featuring Los Angeles Philharmonic, Los Angeles Children’s Chorus, Los Angeles Master Chorale, National Children’s Chorus and Pacific Chorale. The choir has performed with such leading orchestras as the Boston Symphony, National Symphony, Los Angeles Chamber Orchestra, Philharmonia Baroque Orchestra, San Diego Symphony, and Musica Angelica, among others. In addition to receiving national accolades, Pacific Chorale has garnered tremendous international acclaim. In July 2023, the chorus completed its first international tour in seven years with appearances in Austria, Germany and the United Kingdom in collaboration with Bath Philharmonia, Free State Orchestra of Bavaria, and Bournemouth Symphony Chorus and Orchestra. Previous tours have taken the choir to 19 countries in Europe, South America, and Asia, including engagements with the London Symphony, Munich Symphony, L’Orchestre Lamoureux and L’Orchestre de St-Louis-en-l’Île of Paris, National Orchestra of Belgium, China National Symphony, Hong Kong Sinfonietta, Estonian National Symphony, and Orquesta Sinfonica Nacional of Argentina, among others. Deeply committed to making choral music accessible to everyone, the organization has a discography of 14 self-produced recordings and an extensive collection of free digital offerings. Among other artistic highlights, Pacific Chorale’s “The Wayfaring Project,” an original concert film conceived and conducted by Istad and produced during the pandemic, will be streamed through December 1, 2024 on pbsocial.org, kcet.org and the PBS app, reaching audiences around the globe. Pacific Chorale also places significant emphasis on choral music education, providing after-school vocal programs for elementary school students, a choral summer camp for high school students, and an annual community-wide singing event at Segerstrom Center for the Arts.
